- The Green School Parks Designation has officially rolled out! The goal of the <u>Green School Park Program</u> is to create a network of school parks that provide schools and the surrounding community the opportunity to learn from steward and play in nature. Green School Parks are school parks that are inclusive of traditional playground features but more notably have present abundant natural elements woven throughout the greenspace. There are currently 6 GSPs in our District with 10 more schools under (New and improved streamlined) review. We are committed to encouraging even more so we ordered lots of new designation signs to be posted at each new Green School Park!
- Spring It's My Park Day will be March 4, 2023. At least 8 AISD campuses will be IMPD sites. You can sign up here starting Feb 6 to

- The Green School Administrator Cohort & Big Green Jumpstart Grant application is open. The Cohort is a year-long professional-development opportunity to develop strategies for integrating outdoor learning and green campus infrastructure. Principals and partners this is a wonderful opportunity to collaborate! - On January 26th, Austin City Council approved the updated Joint Use agreement between AISD and the City of Austin Parks and Recreation Department. This marks the culmination of a multi-year effort to better support access to nature for students and school communities and improved outdoor learning features at schools.

Transportation & Air Quality Updates



- We are scheduled to receive 3 electric school buses in October 2023 and are currently installing charge stations at our Southeast Terminal.
- Unfortunately AISD was not awarded any grant funds from the Electric School Buses Grant Program from EPA (Environmental Protection Agency) for the first round of grant opportunities over the next 5 years. We will continue to apply for grants with EPA & TCEQ.
- We are open to any ideas on how to generate funds to continue to purchase Electric School Buses as the cost for one electric school bus is nearly 4 times the cost of one Diesel Engine School Bus
- AISD Transportation was in the news regarding proposed legislation (Sentae Bill 238) to help fund electric school buses.

Energy & Water Updates

- · AISD submitted its concept paper for the Department of Energy's Renew America's School Grant to fund rooftop solar and energy efficiency projects. Select applications will be invited to submit a full proposal in April. Fingers crossed!
- The Energy and Water Department in a coordinated effort with Austin Energy through the Energy Engagement program facilitated and distributed over 3 800 Energy All-Star Kits to 6th grader students and teachers to promote educate and help students and communities to save energy and water across the district and at their home.
- We are working on certifying Energy Star Buildings at our qualified campuses. Stay tuned!

- We are creating weekly sustainability goals for our kitchens starting this week all the way through Earth Week. These include things like updating the Share Tables and continuing to offer self serve condiments (reducing single serve containers).
- Our featured Winter menu items include Whole Grain Cheesy Calzones Scratch-made Chili and Cornbread Cuban Chicken Bowls and Hot Honey Drumsticks with Biscuits. In addition we will continue to offer our weekly themed salads and vegetarian offerings at every meal.
- Chef Diane Grodek will present with 2 members of the Center for Environmental Health at the Green Schools Conference in late February sharing successes and challenges from the Cafeteria when it comes to sustainable practices.
- . With grant funding from Austin Ed Fund we completed 2 field trips with about 30 staff members that focused on sustainability global flavors and wellness. Our first sustainability field trip stop was to Texas Disposal Systems to see where our trash compost and recycling goes once it leaves our kitchen. Our second sustainability field trip was to The New World Bakery our local yendor who makes us whole grain preservative-free fresh bread items right down the road in Kyle Texas.
- We celebrated the holidays with a lean towards sustainability by creating a cafeteria decorating competition and encouraged our teams to use only items they already had on hand. You wouldn't believe the creativity that came out of cardboard warehouse boxes empty cans tin foil and packaging materials!

Zero Waste & Procurement Updates



- We have updated sorting signs! They are available to all teachers staff and students in the zero waste toolkit (see right side o this web
- Assessment visits have been performed at high schools by the Zero Waste Lead Ana Echeverria to encourage promote and enforce Waste Sorting practices at the district while engaging personnel to commit to AISD Zero Waste strategies.
- "Reusing" has become part of the strategies promoted by Austin ISD during the 2022-2023 year. With the help of Housekeeping Operations personnel the Energy & Water Department and our painting shop AISD Zero Waste have distributed 7-gallon bins adapted for recycling at elementary schools. These bins originally intended for landfill were donated to the school district through National Instruments and have been repurposed saving money to the school district and diverting resources from the landfill.

Equity & Community Engagement Updates



- The ESAC subcommittee continues to meet bi-weekly. Members are currently reaching out to teachers and students for one-on-one $discussions \ to \ help \ shape \ recruitment \ gaps. \ This \ is \ one \ step \ in \ the \ \underline{Equity \ by \ Design \ framework}} \ that \ we \ are \ using \ to \ guide \ our \ process.$
