

Austin Independent School District / Overview of District Advisory Bodies

District Policy BDF(Local) assigns the administration of each advisory body to either the Superintendent or the Board, and provides standards and expectations for all AISD advisory bodies, including websites, formal bylaws (for standing advisory bodies) or charters (for ad hoc advisory bodies), open meetings, and biennial sunset reviews. Although each advisory body has its own specialized staff assigned to it for support, the Superintendent ensures that a Coordinator of District Advisory bodies provides general oversight for implementation of policy BDF(Local). Bylaws were updated during the 2021-2022 school year and are being implemented beginning this school year.
