Barrington ES	The school is currently scheduled to open in Q3-2026; however, the opening has been postponed to Q3 of 2027	 The originally selected contractor submitted a Guaranteed Maximum Price (GMP) significantly higher than budget expectations, leading to contract termination and the need to onboard a new General Contractor by September 2025. After extensive pre-design analysis revealed undersized and outdated facilities, AISD CMD decided on March 8, 2024 to build a new facility on-site rather than modernizing the existing one. The SDP process has been delayed due to repeated revisions by the City of Austin, extending the expected review timeline.





 - Five other minimum wage claims initiated and pending documentation request and review.



Summary

- OSHA Certification (28 resolved, 6 pending review):
 Resolved through providing proof of active OSHA-10
 and/or 30 certification. Six other claims are in
 documentation request and review.
- Sanitation (1 claim resolved): Contractor promptly delivered a working handwashing station to the job site.
- Worker Intimidation (1 claim resolved): Contractor took immediate action once notified of the incident.
- Break Time Policy (6 claims resolved): Contractor provided additional onboarding training to reinforce rest and bathroom break policies.
- Water Provisions (2 claims resolved): A safety professional met with the contractor team to review potable water policies. Contractor ensured drinkable water was consistently available when workers were on site.

Safety Update



*Note: (Q2 2025): The first incident was a small cut on a worker's forearm caused by shears that were knocked out of another worker's belt, who was on a scissor lift. The second incident was a head injury resulting from the worker falling backward and hitting his head. (Q3 2025): A worker sustained a 2mm puncture wound to his foot from a nail, but medical report showed no bleeding, swelling, tenderness, or foreign debris.

Recent Quarterly Performance

- In Q2 2025 (April June), there were 164,492 recorded man-hours. This represents a significant increase compared to Q1 2025 (January - March), which saw 92,849 man-hours. The growth from Q1 to Q2 highlights a notable ramp-up in activity during the summer months, for targeted and modernization projects.
- Since March 2025, there has been three (3) new recordable incidents.

Actions Taken

- Attended targeted meetings to emphasize the General
 Conditions of the Contract pertaining to safety requirements.
- Met with modernization project managers to review GCC concerning safety.
- Conducted training on construction heat safety and water provisions (e.g., how much water is need on a job site).
- Reviewed recent incidents with AISD construction team discussed how they could have been prevented.
- Distributed the emergency response SOP for construction incidents on AISD campuses to all superintendents.

Project Highlights

- Perimeter fencing, site clearing, and building pad completed



From our records, all scopes listed in the bond book for each bond were completed. These are listed below.

- Our 2013 and 2017 bond projects above included site drainage and grading improvements as well as replacement of doors, walls and sidewalks; however, there was no foundation remediation or structural investigation scoped. Ultimately we were treating symptoms and not the root cause.
- Delco has a long history of drainage and foundation concerns, many of which are related to the expansive clay soil found across much of East Austin.
- We want to acknowledge that a more thorough structural engineering investigation should have been completed to support previous bond projects to appropriately scope and budget for necessary improvements. Due to the lack of structural studies prior to 2013 and 2017 bond planning, projects at Delco were not scoped and budgeted adequately for foundation improvements.
- Had a more comprehensive structural evaluation been performed during those bond projects, we would have budgeted for necessary repairs.
- The district is committed to delivering a long-term, engineering-informed solution for Delco and we are confident that the 2022 bond project has followed a more rigorous and thorough approach with a renewed commitment to serving the community.

- In our 2022 bond (Budget: \$15,000,000) **Austin ISD commissioned a full forensic investigation of the Delco site.** We appreciate your patience as we diligently work through this process towards a solution for long-term performance.
- Between October 2023 and June 2025, multiple specialized reports were completed, including assessments of the building envelope, stormwater management, pile integrity, and soil shrink/swell. The final letter from Millenium Engineering Group (MEG) was received June 23, 2025. MEG is an independent engineer and forensic expert hired to study soil shrink/swell and evaluate the project. MEG provided some recommendations on site drainage, moisture control and moisture barrier. The current design addresses these. MEG reported: "By implementing the design criteria and construction practices previously recommended in conjunction with the above site-specific measures, the potential for shrink-swell related movement can be effectively minimized. This will help ensure the long-term structural performance and serviceability of buildings and infrastructure across the project site."
- Reports to date have not specifically addressed the original 1999 recommendation for pier depths of 18 feet below existing grade. The current construction consists of piers that extend 18 feet below existing grade: 6-foot-deep crawl space with 12-foot-deep piers, which equals 18 feet below existing grade but not 18 feet below the subgrade of the crawlspace. We have an additional independent engineer and forensic expert should be consulted to verify the existing pier depths with currently proposed design will be a successful long-term solution and satisfies the original 1999 report recommending piers depths of 18 feet below existing grade. This additional engineer's evaluation is currently underway, and we expect a report within the next few weeks.





Alternative Learning Center: Coy Site



Project Highlights:

- ALC temporarily relocated from Coy Facility to Mendez Middle School in advance of the 2025–26 school year (Funded by 2022 Bond)
- The move supports redevelopment of the Coy site into mixed-income housing for Austin ISD staff and families and a future rebuild of the ALC





Status of 210022 GARCIA Project

Schedule:

- A Pre-Design Scope Study was completed in November 2024
- The study was discussed, and evaluations and directions were completed in January 2025
- As part of the study recommendations, a survey was recommended, and an agreement was executed in February 2025
- A proposal was submitted by the AE and subsequently a purchasing request for an agreement was issued March 2025
- AISD is holding bi-weekly meetings to complete construction documents
- Construction Documents were due August 2025, but a recent ~\$3M budget cut dictated a scope change; a new budget and associated scope are now being determined/authorized
- Construction Documents are now due December 2025 with a reduced scope of work
- Board approval is expected March 2026
- Construction is expected in summer 2026 and 2027

Budget:

- The total budget is currently about \$6M; the construction budget is estimated at about \$4.5M
- AISD received a Verizon Wireless Lab Grant. AISD is responsible for demo on the grant project, so this project will help minimally by funding that demo work


