

The 2021-22 ratings are the most current ratings for all Texas districts and campuses due to pending legislation.

Special Education Determination Status

Each Texas school district is assigned one of four special education determination levels:

- Meets Requirements,
- Needs Assistance,
- Needs Intervention, or
- Needs Substantial Intervention

Austin ISD was assigned a status of **Needs Assistance**.

This label is based on an evaluation of each district's Results Driven Accountability indicators in the special education program area and four Federally Required Elements.

TAPR: Texas Academic Performance Report

The Texas Academic Performance Report (TAPR) is a state mandated performance report prepared by the Texas Education Agency. The TAPR is published annually, and shared via the district's website and TEA's website.


A report is created for <u>each campus</u> and the <u>district as a whole.</u> The TAPR includes:

TAPR: Attendance Rates

Attendance Rates, 2021-22 and 2022-23




AISD's district-wide attendance rate for school year 2022-23 was 90.9%, down 7.4 percentage points from 2019-20 (98.3%). 2022-23 attendance rates for student groups ranged from a low of 87.5% (African American) to a high of 95.1% (Asian).

Graduation Rates, Class of 2022 & Class of 2023




AISD's district-wide graduation rate for the class of 2023 was 93.1%, which is 2.8 percentage points higher than the state average but 2.5 percentage lower points compared to the class of 2022 (95.6%). Class of 2023 graduation rates for student groups ranged from a low of 80.1% (Special Ed) to a high of 98.7% (Asian). Every student group but Asian saw a loss in Graduation Rates from 2022 to 2023.



TAPR: College, Career and Military Readiness (CCMR)

Percentage of CCMR Graduates, 2021-22 and 2022-23



AISD students who achieved College, Career, and Military readiness in 2022-23 was 82.3%, up 5.2 percentage points compared to 2021-22 (77.1%). 2022-23 CCMR graduates for student groups ranged from a low of 57% (Emergent Bilinguals) to a high of 95.5% (Asian). The CCMR rate for students receiving Special Education services increased 7.8 percentage points compared to 2021-22 (74.9%).








Student and Teacher Race/Ethnicity Side by Side





Teachers by Race/Ethnicity, 2023-24








PEIMS Financial Report

Campus Performance Objectives

Austin ISD utilizes the <u>Strategic Plan</u> and the associated district scorecard to identify, evaluate, and report campus performance objectives throughout the district.

Campus Performance Objectives: Goals 1-3



Goal 1: The percentage of 3rd-grade students earning meets grade level or above on the STAAR Reading Assessment in English or Spanish will increase from 50% in June 2024 to 59% by June 2029. (source: TAMS)

Goal 2: The percentage of 3rd-grade students earning meets grade level or above on the STAAR Math Assessment in English or Spanish will increase from 42% in June 2024 to 55% by June 2029. (source: TAMS)

Goal 3: The percentage of annual graduates who demonstrate CCMR by meeting TSI criteria and at least of one of the following items: earning an associate's degree concurrent with graduation, enrolling at a postsecondary institution following graduation, earning an industry-based certification, or earning a Level I or Level II certificate will increase from 43.7% for the class of 2022 to 54.6% in class of 2027. 
