Baranoff Elementary School is serving a student population of approximately 1,000 students in South Austin. After interviewing the principal, as well as conducting a campus walk assessment, the facility exhibits an overall good condition for educational suitability. Deficiencies found were primarily focused on capacity issues, a lack of space for current and desired programs, and undesirable conditions for pick up and drop off.

Survey Overview

The survey results from teachers and administrators were not completed. The educational suitability for most major spaces, including library, gym, classrooms, common spaces, administrative offices, and outdoor spaces was determined by a principal interview and field assessment.

Interview Overview

Ms. Counihan believes the school is satisfactory overall when compared to other schools in central Texas. The main issues highlighted were issues with pick up and drop off, traffic flow on and around the campus, concerns with the campus being over capacity, and lack of opportunities for small group learning and makerspaces.

Although the campus has adequate spaces such as the library, gym, and classrooms, she was dissatisfied with the common movable wall between the gym and cafeteria. This layout limits scheduling and makes it difficult to have large assemblies due to acoustical issues.

Ms. Counihan also highlighted that the building overall has a good technology infrastructure but technology needs to be more consistent throughout the spaces. Lastly, the principal stressed that safety was an issue with a need for better lighting around the site and at the loading dock for the kitchen. Updated security cameras, and a secure vestibule are also needed.

The items that are most critical for this campus are the need for flex spaces for programs, the pick-up and drop off loop, and the capacity issues.

Assessment Findings

The Educational Suitability Assessment of Baranoff Elementary School earned a 69% overall score and places the campus in a category of "**Good**". The assessment consists of 11 categories to determine the overall score.

Lower Scoring Categories:

Exterior

The score is good.

Traffic circulation for vehicular, bus, and pedestrian traffic is not clearly noted. The building is lacking clear signage and wayfinding and there is only adequate lighting for nighttime use. The outdoor learning spaces are satisfactory, and used throughout the day. Additionally, the play spaces are adequate in size.

Future Ready Student Development

The score is average.

The classroom spaces are adequately sized and have appropriate storage space to accommodate project-based learning. The school lacks adequate display space for student work as well as adequate visual communication tools within classrooms. Only some of the classroom wings contain a flexible learning area.

Security

The score is average.

There is a need for creating a secured entry vestibule to the school. There is key card access at all major entries. The interior transparency is good for faculty supervision within the school. Due to the high enrollment in the school, there are portables on the property. This causes students to travel through the parking lot at the same time with vehicles, causing an unsafe situation. Site lighting needs to be evaluated, due to the amount of community use at the playgrounds and fields.

Technology

The score is average.

Common facilities lack instructional technology, although the classrooms do have computers. Projectors need to be provided in the classrooms. Currently the projectors vary from being on carts to ceiling hung. Chalk boards need to be removed and marker boards need to be installed.

Furniture, Fixtures & Equipment

The score is average.

The furniture is in good condition and size, but does not allow for easy reconfiguration of the space for different learning groups. The library furniture should be evaluated to allow for easier movement for group activities.

Environmental Quality

The score is good.

The quality of the artificial lighting is appropriate for classroom functions, while the acoustics are inadequate as sounds are easily heard from the corridor and adjacent classroom spaces. A large percentage of the learning spaces have natural lighting.

Academic & Co-Curricular Support

The score is good.

Overall, the facility's chairs and desks are not flexible to allow for different group sizes and teaching methods. Science classrooms are typical classrooms being reused as a science classroom. There is no science lab. Kinder spaces are satisfactory for storage and configuration, but a door or wall is needed to separate them for sound concerns. The dining facility's number of serving lines needs to be evaluated for the school's needs.

Library/Media Center

The score is excellent.

The library has flexibility for collaborative work of different group sizes. There is a need for other casual seating to support social interaction and separation for areas for individual study. In addition, the library has satisfactory technological support. Visually the library needs some updating, but the space is appropriate. Moveable furniture would help the use of this space.

General Building

The score is good.

The access for community functions and the general appearance of the school including the main entry are nice attributes. The arrangement of school spaces allow nighttime use of the school and the corridors are average in width.

Controllability of Systems

The score is good.

The classrooms have individual thermal controls and effective shades for controlling natural light. However, the artificial lighting controls are limited to only one on/off switch which is very unsatisfactory for artificial lighting level control.

Storage

The score is good.

General building storage is adequate and allocated throughout the building. Additionally, classroom storage spaces are equipped with built-in cabinets. Some classrooms have storage closets in addition to built in cabinets.
