



# **Educational Suitability Summary Report**

Casey Elementary School

Date: 8/8/2016 Score 72% Good

Casey Elementary school serves a student population of approximately 600 students in South Austin. After interviewing the principal, as well as conducting a campus walk assessment, the facility exhibits an overall good condition for educational suitability. Deficiencies found were primarily focused on being at capacity, the need for updated technology, furniture and storage space.

## **Survey Overview**

Survey results from a teachers and administrators give a satisfied level of educational suitability for most major spaces. An unsatisfied response was received for the library, art rooms, common spaces, administrative offices, and playground. The main spaces needed were Hands-on project spaces and an expansion of the teacher's lounge and administrative offices. But overall the physical condition and building image of the school is considered to be satisfactory.

#### **Interview Overview**

From the interview with the principal, the main spaces thought to not be suitable was the portable being used for the travelling music and art programs. The concern is that the school is currently built for a capacity of 600 students and it is right at capacity and needs more storage space. The principal desires more playscape equipment due to the amount of students. The furniture for the classrooms is dated and not flexible. Currently most classrooms have tables with chairs. The Pre-K classrooms need lower, more appropriate furniture for visibility. The projectors and innovation stations are dated and some are at end of life. The principal expressed interest in having more afterschool enrichment programs such as prime time. Also, there is a need for Community in Schools, ACE mentoring, a STEAM academy, and a maker space. Currently the campus is seeking grants to assist with creating a media broadcast room and an outdoor gym and classroom.

The principal has expressed some safety concerns on the campus with some cafeteria tables that do not latch properly when stored. More fencing is needed to keep kids from running out toward high traffic on Slaughter Lane, which has occurred previously. The campus only has two doors with badge access, and lacks exterior lighting at the front entry and the parking lots. Pre-K classrooms need lower furniture for better visibility to supervise the children.

Should any major renovations occur on campus, measures should be taken to preserve or salvage the natural areas with trees and preserve the Brighter Bites program.

The campus, being a relatively newer school, has a few areas for improvement of which the highest priority include more storage, added fencing to keep students from quick access to busy streets, developed outdoor learning spaces, and expanded administration and teacher lounge.

#### **Assessment Findings**

The Educational Suitability Assessment of Casey Elementary earned an 72% overall score and places the campus in a category of good. The assessment consists of 11 categories to determine areas that need more attention.

## **Lower Scoring Categories:**

## Library/Media Center

The score is average.

There is a need for casual seating to support social interaction and separation in areas for individual study. In addition, the library has satisfactory technological support. The library is small and lacks a tiered seating area. The round tables are better suited for small groups than larger groups.

#### Security

The score is average.

The location of the central office is very satisfactory and close to the front entry. Key card access is lacking at the exterior doors. Additional lighting is needed at the parking lots and front entry. Classroom doors have windows along with a window adjacent for more visibility into corridors.

#### Storage

The score is average.

General building storage is inadequate. Classroom storage spaces are equipped with built-in cabinets but appear to be filled to capacity. Student storage consists of hooks in corridors.

# Furniture, Fixtures & Equipment

The score is average.

The furniture is in worn condition and has easier reconfiguration with loose tables and chairs but has its limitations unlike with desks and chairs.

#### **Higher Scoring Categories:**

#### **Exterior**

The score is good.

Traffic circulation for vehicular, bus, and pedestrian traffic are separate. The building could use some additional lighting for nighttime use. There is some opportunity for outdoor learning spaces, but it is not fully developed. The play spaces are not adequate in size, and the track and play field are insufficient for the amount of use.

## Casey Elementary School

#### **Academic & Co-Curricular Support**

The score is good.

Pre-K, kinder classrooms and support spaces are appropriately configured. Some have direct doors to the playground. The gym is well configured but it has a small amount of storage space. The music room is a converted classroom with a moderate amount of storage. The art room and computer lab are moderately sized and have dated and worn furniture.

#### **Future Ready Student Development**

The score is good.

The classroom spaces are adequately sized and but need more storage space to accommodate project-based learning. Common spaces exist and additionally, the school has adequate display space for student work as well as adequate visual communication tools within the classrooms. The campus provides opportunities for social interaction and sufficient areas to display students' work.

# **Technology**

The score is good.

The common facilities have a mix of new and outdated instructional technology. Classrooms have computers, and projectors, but need some updating and connectivity in classrooms. There are 2-3 outlets per wall, which is sufficient.

### **General Building**

The score is excellent.

The access for community functions and the general appearance of the school including the main entry are nice attributes. The arrangement of school spaces allow for relative ease for nighttime use of the school.

#### **Environmental Quality**

The score is excellent.

The quality of the artificial lighting is appropriate for classroom functions. The acoustics are adequate as sounds are not easily heard from the corridor. All classrooms have adequate amount of natural light and exterior views as well as good levels and quality of artificial lighting.

#### **Controllability of Systems**

The score is excellent.

The classrooms have individual thermal controls and effective shades for controlling natural light. The light controls are on alternating rows of switches.






