Dobie Pre-Kindergarten Center, serving a student population of approximately 300 students, is located on the Dobie Middle School campus in north Austin. It should be noted that the low score for Dobie Pre-Kindergarten Center is not a reflection of its programs or its administration, but strictly a reflection of the suitability of their current spaces for optimum learning. The fact that there is no dedicated building space but rather a collection of 17 portable classrooms significantly contributed to many factors lowering this score. The highest priorities for the administration are safety and security issues which include the uncovered walkways, the need for heated walkways in the winter, and a safe evacuation route. Many of the campus concerns would be solved with a dedicated school building.

Survey Overview

The survey for teachers and administrators has received no responses.

Interview Overview

The in-person interview at Dobie Pre-Kindergarten Center was attended by the principal, Courtney Roberson. The interview was followed by a walk-through with Mrs. Roberson to discuss the specific needs of this campus. The most glaring inadequacy of the campus is that the entire campus is in portables. There are no building spaces. This contributes to the majority of the concerns on campus. The campus would greatly benefit from having a dedicated school building.

The three newest portables on campus do not have appropriate walkway coverings or awnings to protect young children from the weather. The campus has collected parent signatures to petition to have these added, but they still have not been added, years later. The campus also needs heaters mounted to the underside of the covered pathways for students during cold weather. The campus is also lacking a restroom in one of the two cafeteria portables. The office and meeting space needs upgrades. The current meeting space is in a portable on the outside of campus very far from the front office and with inadequate furniture or space. The gymnasium is a portable without an appropriate audio system or any type of athletic floor. The campus storage is very limited, and they are using outdoor storage sheds to keep custodial supplies and trikes. The parking is limited to on-street parking which is causing issues with neighbors and increased traffic. There is no appropriate ADA parking area either. The air conditioning units in portables are loud and interfere with meetings and instruction.

The administration would like to have the ability to have televised announcements, additional technology for classrooms, and additional subscriptions to technology and resources for instruction. She strongly desires a performance space for the campus. Due to a lack of assembly space, they are currently conducting seven consecutive graduation ceremonies outdoors. There is a desire for increased signage in the form of an electronic marquee. There is also an expressed desire for

developed outdoor learning spaces with picnic areas, gardens, and trees. They also need a shaded area for parents waiting to pick up their children in the afternoon heat.

The campus administration would love to have the space for a 3-year old program and Kindergarten classes, but there is not any available space. There is expressed interest in these programs from parents.

There are several safety concerns on the campus. The campus has a low chain-link fence around the perimeter which is not successful at maintaining security. There are reports of people climbing onto the roofs and covered walkways causing damage. Additionally, the announcement and communication system needs upgrades to be able to communicate with all of the rooms. In the event of emergencies, the campus evacuates to the middle school. However, there is not a continuous, handicapped accessible path to the middle school which is a safety concern for the faculty. The campus also lacks adequate site lighting and adequate video surveillance.

The school administration is receptive to any positive changes to the campus, and believes that in the next twenty years, early childcare will become increasingly important. She asserts that early childcare helps students learn fundamentals early and prepares them better for future educational success. In terms of the campus needs, she reports the highest priority as addressing the safety and security issues including covering the uncovered pathways, adding outdoor heaters for the winter, and creating a safe evacuation pathway. They also really need a restroom for the second cafeteria space. The creation of a replacement building for this campus, would solve many of the school's current problems.

Assessment Findings

The Educational Suitability Assessment of Dobie Pre-Kindergarten Center earned a 35% overall score and places the campus in a category of very unsatisfactory. The assessment consists of 11 categories to determine areas that need more attention.

Lower Scoring Categories: Very Unsatisfactory and Unsatisfactory Categories

Future Ready Student Development

The score is very unsatisfactory.

The classroom spaces are inadequately sized and lack appropriate storage space to accommodate project-based learning. There are very few areas for displaying student work with limited classroom wall space and no hallways on the campus. The meeting space for the facility is located in a portable very far from the front office portable, actually outside of the boundary fence of the school. This portable has outdated, non-matching furniture and undersized meeting space. This area is shared by parent resource and the PTA. They also use this space for ARD meetings. There is very limited classroom area dedicated to visual communication tools. There is only one whiteboard and one adjacent tack board in most classrooms. They have projectors as well.

Storage

The score is very unsatisfactory.

General building storage is in the form of exterior storage sheds and a few supply closets. There is a lack of secure file storage as well. The classroom and student storage is limited and being supplemented by older bookcases and shelves.

Exterior

The score is very unsatisfactory.

There is no separation of traffic. The drop off area is along a busy road across from private residences. Parking is limited to on-street parking which creates conflicts with the neighbors. The pick-up procedure involves parents walking to their children's classrooms to receive them, but there is no covered area for parents to wait to pick up children. There are reports of parents passing out from the heat while waiting to get their children. There are not developed areas for outdoor learning. The outdoor play space is undersized and needs additional shade. There is signage on the campus portables for the shared spaces, but the exterior signage is less apparent.

Academic & Co-Curricular Support

The score is very unsatisfactory.

The gymnasium is in a portable. There is a poorly functioning stereo and a restroom. There is no athletic flooring or equipment expected in a typical physical education space. There is no performance space for the campus. Because of this, the graduation ceremony has to be split into seven consecutive ceremonies. There are no dedicated special education spaces, but the support for special needs students is problematic. There are serious accessibility concerns at the campus. The emergency evacuation pathway for the campus is to the adjacent middle school along an ADA non-compliant path. The sidewalk is discontinuous and in poor condition. There is no ADA parking area on the campus either. The dining facilities are two portables. One of these has a restroom and nicer serving equipment, while the other has makeshift equipment and no restroom. This causes inefficiencies and challenges for teachers.

Security

The score is very unsatisfactory.

The portables do not have keycard access and some portables are located outside of the campus fence. The location of the central office portable does not create a secure entry sequence. Visitors can gain access to any classroom without being seen by the office. Site lighting and video surveillance needs upgrading. The campus communication system needs improvement as well to be able to reach all of the classrooms. There are several blind spots and supervision challenges on the campus due to the sprawling layout of 17 separate portable buildings.

General Building

The score is very unsatisfactory.

The walkways are narrow and they are a mix of covered exterior walkways and uncovered exterior walkways. The metal ramps ice in cold weather and can burn students in warm weather. The school consists entirely of portables. There are no large assembly spaces for

group meetings. The gym, cafeteria, and library are all individual portables. The appearance is low scoring due to the campus being a collection of portables. They have done a good job painting them bright colors and making it a cheerful looking campus, but this configuration does not welcome the community or showcase student work.

Technology

The score is unsatisfactory.

There are a few computers and devices in classrooms, but they are limited. The facility needs increased technology. There is limited access to power and data in the classrooms.

Environmental Quality

The score is unsatisfactory.

The quality of the artificial lighting is appropriate for classroom functions, although it is not distributed well in some spaces. The acoustics are poor due to the loud air conditioner units that are interrupting instruction. The access to natural light and views is very limited due to the small portable windows. They campus reports issues with roaches throughout the facility.

Higher Scoring Categories: Average Categories

Furniture, Fixtures & Equipment

The score is average.

Furniture is average in condition, but does not allow for easy reconfiguration of the space for different learning groups due to the size of most tables.

Library/Media Center

The score is average.

The library has limited space, but it accommodates social interaction and small groups. The space is limited for larger groups and quiet study. The technological support is present, but they would like more devices for students with heavy-duty protective cases. They also would like more books that are durable for use by young children. The space is not appropriately configured for community use due to its location within the larger campus, and the limited space is not ideal for community gatherings.

Controllability of Systems

The score is average.

The classrooms have individual thermal controls and effective shades for controlling natural light. However, the artificial lighting controls are limited to only one on/off switch which is very unsatisfactory for artificial lighting level control.




