Jordan Elementary school, serving a student population of approximately 670 students in east Austin, was originally built in 1993. After interviewing both the Principal and Vice Principal as well as conducting a campus walk assessment, the facility exhibits an overall good score for educational suitability. Deficiencies found were primarily focused on security, a lack of space for current and desired programs, and undesirable conditions of exterior spaces.

Survey Overview

Ms. Bocanegra, a Jordan ES faculty member, believes the school is overall unsatisfactory especially when compared to other schools in central Texas. The main issues highlighted are a general lack of storage, a shortage of quiet, independent study areas, and lack of opportunities for small group learning. Although the campus has adequate spaces such as the library, gym, and classrooms, she is dissatisfied with the common and administrative areas (i.e. restrooms, playfields, and counselor offices). She also highlighted that the overall building condition is poor, citing leaks, mold, and broken doors. Lastly, Ms. Bocanegra stressed that safety is an issue, and there is a need for better signage and fencing around the playground, added security cameras, and a secure vestibule.

Interview Overview

In talking with the Principal and Vice Principal, there are a few current school programs that are being held in unsuitable spaces. Of particular note, the cafetorium and gym are separated by thin and dated folding partitions which cause many acoustic issues. Additionally, the current computer lab is undersized and lacks dedicated, secure storage. The existing track is frequently used but is uneven, riddled with potholes, and lined with sharp limestone blocks that are tripping hazards.

Programmatic needs are as follows: STEM and Arts programs (math lab, drama class, photography, etc.) and dedicated space to teach such curriculum, updated technology with appropriate lifespans, and afterschool programs with associated outdoor spaces.

In planning for the next twenty years of teaching development, technology is assumed to be the primary focus. There is a desire for a campus-wide video network for broadcasting and campus-wide learning opportunities as well as a general desire for dedicated STEM classes (Arts classes, maker space, broadcasting room, etc.) Additionally, shaded outdoor learning spaces and flexible common spaces throughout the existing school are desired.

The most critical issues are focused on campus security and safety.

Items that should be held sacred or hold a seat of pride should the school be renovated or rebuilt are as

follows: all Barbara Johnson memorabilia (needs centralized, dedicated display), the rain garden planted by the students, staff, and community, and the vegetable garden recently planted behind the existing portables.

Assessment Findings

The Educational Suitability Assessment of Jordan ES earned a 72% overall score and places the campus in a category of "good." The assessment consists of 11 categories to determine areas that need more attention.

Lower Scoring Categories:

General Building

Score is unsatisfactory.

The general appearance of the school shows pride, but the access for community functions needs security upgrades. The arrangement of school spaces allows nighttime use of the school as all main spaces are located together and near the main entrance. However, there is currently no way for the classroom corridors to be secured from the public during such events. Corridors are average in width and height, and a large lobby serves the main entrance and the library.

Controllability of Systems

Score is unsatisfactory.

The classrooms feature standard, zoned thermal controls and have manual shades for controlling natural light. Artificial lighting controls are limited to only one on/off switch, which results in unsatisfactory artificial lighting level control. Some classrooms lights have been covered with colored films in order to mitigate inconsistent lighting levels and the uncomfortable fluorescent color index.

Security

Score is very unsatisfactory.

The location of the central office is satisfactory, but the main entrance for visitors does not pass through administration space. Key card access is not at all major entries and security camera coverage is spotty. Video surveillance is especially lacking at the portables and the back entrances of the classroom wings. The perimeter of the campus is porous, and resultantly the school is frequented by unwanted guests both indoors and outdoors during daily activities. Another reported concern is that there is no way for teachers to lock their classroom doors from the inside, which is dangerous in the event of an attack scenario. It is reported that door hardware is desired to accommodate this type of drill or some form of supplementary protection.

Technology

Score is average.

Common facilities have dated instructional technologies. It is reported that projectors break frequently and are often not replaced. TVs are provided in most classrooms, but are not connected to a central system for announcements or other schoolwide broadcasts. The school administration desires a "green room" or "broadcasting room" in order to facilitate building-wide A/V announcements and educational video streams. Classrooms have access to mobile computers and power locations are appropriate within classrooms.

Higher Scoring Categories:

Exterior

Score is good.

The circulation for vehicular, bus, and pedestrian traffic is separated and clearly identified. The building interior lacks clear signage and wayfinding. However, there is sufficient building lighting for nighttime use. Outdoor learning spaces are unsatisfactory due to lack of shade and multiple safety issues including a porous perimeter fence and tripping hazards in the form of hard limestone blocks at playscapes and multiple large stormwater drains.

Academic & Co-Curricular Support

Score is good.

Overall, the facility's chairs and desks show little wear, and the loose chairs and tables allow for flexible group sizes and teaching methods. Kinder and Pre-K spaces are satisfactory for storage and offer flexible configuration. The only science classroom on campus is currently housed in half of a portable building. The size of rooms and the associated support spaces are very unsatisfactory for science classroom needs. The gym is of adequate size and is located appropriately in the building. Athletic support spaces are located in close proximity and are an adequate size. The corridor adjacent to the gym offers quick access to outdoor space, but the outdoor areas are unsuitable for student activities as noted in the exterior category above. The art and music rooms meet the program needs, but the cafetorium stage is small, dated, and lacks storage space. Currently, the stage and associated access areas are being used for storage. The computer class is located centrally in the school and has direct access to the library. Computer storage and support spaces are nonexistent, so equipment storage is being allocated throughout the school in unsecured locations. The cafeteria and dining areas are adequately sized and configured.

Future Ready Student Development

Score is good.

The classroom spaces are adequately sized and have appropriate storage space to accommodate project-based learning. The school has adequate display space for student work as well as adequate visual communication tools within classrooms and corridors. Only one shared common area is located in the 400 wing. Technology is inadequate for future ready student development.

Furniture, Fixtures & Equipment

Score is good.

Furniture is satisfactory in condition and size and allows for easy reconfiguration of the space for different learning groups.

Environmental Quality

Score is Excellent.

The quality of the artificial lighting is appropriate for classroom functions, and the acoustics are satisfactory in the classroom spaces. The majority of learning spaces have exterior views and access to natural light. The common space in the 400 wing has no blinds or shades at the clerestory windows. Currently, the faculty have covered the windows with paper and films to block light from entering the space when the projector is in use. This is reported as a mildew issue due to condensation collecting on these paper and film coverings.

Storage

Score is good.

The principal and vice principal stated that general building storage is very adequate and located well throughout the school. Classrooms are all equipped with storage cabinets and closets as well as student storage units.

Library/Media Center

Score is excellent.

The library has an adequately sized space and offers flexibility for collaborative work of different group sizes. However, the space is a bit crowded and would benefit from additional collaborative space. The amphitheater nook is a nice space but has outdated technology. A small bank of computers serves as the media center of the library. The library has direct access to an outdoor courtyard that needs some updates and maintenance to be suitable for outdoor learning.
