Patton Elementary School, serving a student population of approximately 950 students in South Austin, is housed in an older building that has some effective spaces for learning. The main priorities expressed by the administration for this campus are increasing the technology, improving the traffic circulation and parking, and adding additional classroom spaces to replace the portables.

Survey Overview

Survey results from the principal, Dr. Amanda Brantley, report that she is "very unsatisfied" with the educational suitability of the library, cafeteria, administrative offices, restrooms, portables, and the unsecure vestibule entry to the building. The physical condition of the restrooms, the condition of the school grounds, and the security of the outdoor spaces are reported as unsatisfactory as well. The only spaces that were reported as "satisfactory" are the common spaces and the gymnasium. The spaces desired on the campus include assembly space and additional classrooms in the building to replace the portables. The offices and administration space are reported as very unsatisfactory and limited in space. The pick-up and drop-off area of the campus is another unsatisfactory area. The responses list a need for separation of bus, vehicle, and pedestrian traffic and a longer cueing area for cars to reduce neighborhood traffic. She would like the campus to have mentor space, exterior entries to the library and cafeteria, and community access to computer labs in order to increase community participation at the school. She does believe this campus is considered a community landmark.

Interview Overview

The interview conducted by Perkins Will at Patton Elementary for educational suitability was attended by the principal Dr. Amanda Brantley. The areas of the school that she finds unsuitable for educational suitability are the undersized administration office area, the portables, the cafeteria, the restrooms, the library, and storage areas. She expressed that the building is dated and does not show school spirit. There is very little storage on the campus, and there is a large shipping container being used as a custodial storage space. The furniture is old and outdated, and the acoustics are poor. The school is overcrowded, and there are 16 classrooms in portables. These portables do not have covered walkways, and students must walk through a parking lot to access them, causing safety concerns. The vehicular circulation is also a concern due to the small stack space, which results in larger traffic issues in the neighborhood.

The principal would like to have additional teacher workspaces and office space in the building. She would like there to be covered walkways to the portables for student safety. The campus also needs more outdoor learning spaces, and a larger front loop to accommodate more vehicle stack space and additional parking. The school is overcrowded, and the administration desires additional classroom spaces in the main building to replace the portables.

The building has a large rat and roach issue throughout the campus. Roaches were observed running through classrooms and hallways during the assessment. There is no secure vestibule into the building, and the many entrances to the building make it difficult to supervise. The site lighting needs additional updates, but the camera surveillance system is reported as adequate due to recent updates. The fire alarm and communication system is very poor and cannot be heard by some of the classrooms and portables, which is a critical safety issue.

The common areas and the character of the building are important to maintain. In the next twenty years, the principal expressed her belief that the typical classroom will transition to an outdoor learning space. Technology will also be important because education will become increasingly student-driven. Her opinion is that the district needs to plan for updates in advance to help create equity across campuses. Currently the PTA at Patton Elementary School is buying all the new technology and equipment for the campus.

The most important issues for the campus are increasing technology, improving the poor traffic circulation and limited parking, and increasing classroom space to replace portables.

Assessment Findings

The Educational Suitability Assessment of Patton Elementary School earned a 63% overall score and places the campus in a category of average. The assessment consists of 11 categories to determine areas that need more attention.

Lower Scoring Categories: Unsatisfactory Categories

Technology

The score is unsatisfactory.

There is a mix of older and newer technology in the form of projectors and some innovation stations. There are very few whiteboards as well. There is an adequate number of power outlets and data ports in the learning spaces.

Storage

The score is unsatisfactory.

The general building storage is inadequate. There is a shipping container on campus storing custodial supplies. The classroom storage is limited to built-in cabinets that are dated but still functioning well in most spaces. Student storage is accommodated by the furniture and wall hooks.

Furniture, Fixtures & Equipment

The score is unsatisfactory.

The campus has outdated furniture. This furniture is unsatisfactory for flexible configurations due to the mix of furniture styles. Teacher desks are in poor condition in some of the classrooms.

Higher Scoring Categories: Average and Good Categories

Controllability of Systems

The score is average.

The classrooms have functional thermal controls but there is inadequate artificial lighting control in the form of only one on/off light switch. The classrooms have blinds for controlling natural light that are in moderate condition.

Exterior

The score is average.

The vehicular circulation is an issue due to a small stack space area that causes traffic issues in the neighborhood during pick-up and drop-off. There are some outdoor learning spaces that need some additional development. The playground has a variety of equipment and a shaded playground area. However, these areas could use some additional shade and equipment updates. The building has some signage and color-coded wings for easy wayfinding.

Academic & Co-Curricular Support

The score is average.

The Pre-K and Kindergarten areas are appropriately configured but the storage and the restrooms are dated. Athletic spaces are sufficient and the support spaces are well-sized. The music classrooms are small but the stage area is in good condition. The art room is a converted classroom that needs additional storage and upgraded equipment. The special education spaces are also converted classrooms that need upgraded storage and improved equipment. The cafeteria is a moderate size, but is sufficient for the current needs of the campus. There is no ADA access to the stage.

Environmental Quality

The score is good.

The quality of the artificial lighting is appropriate for classroom functions, and most of the learning spaces have exterior views and nice natural light. However, there are some pest issues in the form of rats and roaches reported by school administration.

Security

The score is good.

The location of the central office does not create a secure vestibule for the campus; however it is located at the front entry for supervision of those entering the school. Key card access is at all major entries, and the interior transparency is very good for faculty supervision within the school. Site lighting around the campus is unsatisfactory and needs upgrades. Portables need covered walkways to protect students from poor weather conditions.

Future Ready Student Development

The score is good.

The campus classrooms are adequate in size to accommodate hands-on project-based learning although the support space is limited. The meeting space is limited but the common

"pod" areas allow for small group collaborations for groups of different sizes. The facility lacks consistent visual communication tools across classrooms. There are some projectors and innovation stations, but some of this technology is quite outdated.

General Building

The score is good.

The cafeteria and gymnasium are accessible from the main hallway and can be secured from the rest of the building for community functions. The general appearance of the school is good despite some older finishes. The main entryway is well-sized and bright.

Library/Media Center

The score is good.

The library has space and flexibility for collaborative work of different group sizes. There is a learning stair and some casual seating for more informal interactions. The library needs more separation for quiet study and upgraded technology for students.
