Wooten Elementary serves a student population of approximately 650 students in North Austin. From the interview with faculty and campus assessments, the campus demonstrates overall conditions of 'unsatisfactory' for educational suitability. A variety of deficiencies were noted as unsatisfactory, including the lack of proper support spaces for the campus. Other items that are not adequate are the special education and fine arts spaces that do not have the correct support or equipment, to support the program. There is inadequate technology in the classrooms and the support space. The campus recently received new classroom furniture, and the new desks and furniture are helping for flexibility of learning spaces.

Survey Overview

Teachers and community members participated and completed the online ESA survey. The survey indicated that the campus was unsatisfactory when compared to other schools in central Texas. The survey also indicated that the campus did not feel safe for parents and students. Some of the main areas that were highlighted as unsatisfactory included the gym, classrooms, restrooms, common spaces, athletic fields and playgrounds. The survey indicated a need for assembly space, storage, hands-on project spaces, and small group learning areas. There was a general consensus from the survey responses that indicated a dissatisfaction with the physical condition of the school, the temperature control in the school, condition of the public areas, and condition of the grounds for sports opportunities. Technological improvements leaned toward devices such as laptops and tablets as a way to improve learning spaces. Lastly, the survey indicated a need for longer cueing of cars on site to reduce neighborhood traffic, and the need to separate pedestrians and vehicles.

Interview Overview

The principal, Angelo San Segundo, was present for the interview process of the assessment. Discussions around programs that are currently being provided at the campus show that Special Ed, Fine Arts and general campus support is not easily achieved with the original design of the building. Due to current enrollment, and a lack of restrooms, and adequate space, special education programs are all housed in portables. Life skills does not have kitchenette or restrooms, and in order to change student, the staff must bring children inside the main building.

The music and art classrooms are standard classrooms that have been converted to meet the need of these specialized spaces. The classrooms do not have the support spaces that the current AISD Ed spec requires. There are no storage spaces for these programs. The gym is small and can only hold one class. The storage here is also limited.

The corridor spaces are adequate in width, but the low ceiling creates an uninviting feeling to the campus. To reach some classrooms, the student and teachers must go outdoors to reach their destinations, which becomes a security concern.

Security at the campus is similar to campuses across AISD. Specific concerns for this campus are that there is no secured vestibule at the entry, the location of security cameras needs to be evaluated, and exterior lighting needs to be provided at select locations around the campus. The fact that there is no onsite drives creates a concern for staff, especially during pick up and drop off periods. The parents are forced to drop off on the public streets, and the staff cannot control where parents chose to do this. Way finding is another security issue. Finding the front door is difficult if you are not familiar with the campus. There are many exits and entrances to the building, and this is difficult to monitor throughout the day.

A growing interest at the campus are program such as coding, robotics, and printing. Additional spaces like maker spaces, science labs and other multi use spaces would allow the campus to provide these programs to the students. If an addition were to occur at this campus, infilling the courtyard with the exterior circulation would be preferred.

The campus is desperately in need of support spaces for administration and staff. The lack of storage closets has forced the campus to use metal containers placed around the campus. The principal's office is also the campuses conference room. Additional administration and support spaces would help the entire campus.

Assessment Findings

The Educational Suitability Assessment of Wooten Elementary earned a 50% overall score and places the campus in a category of unsatisfactory. The assessment consists of 11 categories to determine areas that need more attention.

Lower Scoring Categories:

General Building

The score is very unsatisfactory.

The access for community functions does not allow for direct access from the exterior. The floor plan does not allow for common areas to be used and the rest of the campus to be locked down. The general appearance of the school, including the main entry, are showing age. The front door is difficult to find if you are not familiar with the campus. The corridors are average in width, but the ceiling heights are low. The window systems are in need of repair or replacement.

Future Ready Student Development

The score is unsatisfactory.

The classroom spaces are adequately sized, but lack appropriate storage space to accommodate teachers and the needs of students. The floor plan does not allow for flex or support spaces. The furniture helps alleviate some of the issues that are building related, but the classrooms need updates to assist teaching.

Storage

The score is unsatisfactory.

General building storage is very inadequate and allocated to the corridors. Additionally, classroom storage spaces are equipped with only minimal built-in cabinets that are in need of replacement. The campus currently stores records and other items in metal storage containers placed around the campus.

Academic & Co-Curricular Support

The score is very unsatisfactory.

Overall, the facility's chairs and desks are flexible and allow for different group sizes and teaching methods. The size of support spaces are very unsatisfactory for campus needs. Kinder and Pre-K spaces are not separate from the main building, and are unsatisfactory for storage and configuration. Athletic support spaces are insufficient in size and lack lighting. The dining facility's seating area is too small for the school's needs. There is not enough room for custodian and support staff. There is not enough room for administrative staff and admin support spaces. Art and music are in standard classrooms without the support spaces that are needed. One wing is required to travel outdoors to get to their rooms. Almost half the population is allocated to portables. The SPED classes need specialized spaces.

Security

The score is unsatisfactory.

The location of the central office is satisfactory in configuration for creating a secure entry to the school, but does not exist. Key card access is at all major entries. Interior transparency is very good for faculty supervision within the school. Travel outside occurs for one classroom wing. Almost half the student population is in portables, with students travelling back and forth between the main building and portable buildings throughout the day.

Higher Scoring Categories:

Exterior

The score is average.

Traffic circulation for vehicular, bus, and pedestrian traffic is not clearly noted. Parent pick up and drop off occurs on public streets, as there is limited parking on campus drives. The building is lacking clear signage and wayfinding. The small parking lot at the front of the building does not line up with the front entry. The rear parking lot needs to be resealed. Exterior lighting for nighttime use needs to be evaluated. Outdoor learning spaces are satisfactory, but could use some minor improvements to encourage more use. Additionally, the play spaces are adequate in size, but could be more appropriately located in relation to the gym.

Library/Media Center

The score is good.

The library has different types of spaces for flexibility of collaborative work with different group sizes. There is a need for other casual seating to support social interaction. Although the library

is dark and the ceiling height is low, there are separate areas for small group study.

Technology

The score is average.

Classrooms have computers and projectors. Classrooms also have innovations stations, but these devices are at an end of life phase. Power locations could be improved to reduce extension cord use. The computer lab is a standard classroom that has been converted to a lab.

Furniture, Fixtures & Equipment

The score is excellent.

Furniture is new and in good condition and size. The furniture allows for easy reconfiguration of the space for different learning groups.

Controllability of Systems

The score is average.

The classrooms have individual thermal controls and effective shades for controlling natural light. However, the artificial lighting controls are limited to only one on/off switch which is very unsatisfactory for artificial lighting level control.

Environmental Quality

The score is good.

The quality of the artificial lighting is appropriate for classroom functions. The acoustics are inadequate in the 300 wing, as sounds are easily heard from the corridor due to louvers at the base of the wall. Almost all learning spaces have exterior views and access to natural daylight. Window repairs need to occur to adjust for better management of HVAC and climate control in the classrooms and lounge area.

Additional CAC Comments (1/11/2017)

CAC would like additional windows in Pre-K rooms, for the exterior doors to lock automatically at the 200 wing, and to cover outdoor learning areas with sun protection. They also would like to have covered exterior walk ways to the portables. They comment that the main office is too small and is not a good area for parents to enter due to crowding. They also comment that the Pre-K hallway is L-shaped and that they have emergency exit concerns. They assert that the doors are heavy in Pre-K – Grade 1 and students cannot see above the windows. The CAC wants to paint the interior hallways and to check the Pre-K walls. They would also like more adult restrooms, restrooms for the cafeteria, and a student restroom in the library. They also mention that cafeteria HVAC smells moldy, and believe there are possible drainage issues. They also mention the need for fencing around the HVAC units by the gym.
