



# **Educational Suitability Summary Report**

Ridgeview Alternative Learning Center

Date: 08/2/2016 Score 42% Unsatisfactory

Ridgeview Alternative Learning Center, located in East Austin, is serving a fluctuating student population of approximately 115 students that have social behavioral and disciplinary issues. Within a school year, the school will serve approximately 1,000 different students. After interviewing with staff, as well as conducting a campus walk assessment, the facility exhibits an overall unsatisfactory condition for educational suitability. Deficiencies found were primarily focused on a great portion of the building being condemned and being used as a storage area for the district.

#### **Survey Overview**

No survey results have been received at this time.

#### Interview Overview

From the interview with staff members, one third of the school is condemned and not habitable. The campus is among the oldest in the district and was once Anderson High School and still hosts reunions. The science labs have fixed tables and are not appropriate configuration. These class rooms do not have proper electrical capacity, gas, ventilation, or plumbing. A typical classroom has to be used as a science room. The boys and girls club is currently housed in part of the inhabitable space of the building. There is a lack of storage space for the school because the current storage spaces are used as 'dumping grounds' by AISD. The bookroom is within the condemned part of the building and is without power. The tech room has been converted into a copy room. Half of the technology is outdated and the Wi-Fi throughout the building is extremely poor. The cafeteria has no drinking faucet or ice. Portables on the campus are sized for elementary school students and are used by Travis County Juvenile Justice system for serious offenders. Only half of the classrooms have proper visual communication tools. The two conference rooms on campus do not have any technology connectivity. The campus has no extracurricular programs such as art or music. The overall appearance of the campus is poor and there are accessibility issues. The teachers have no dedicated workroom or lounge and restrooms in general are inadequate in size and number.

The school is in a fully functional spaces with adequate technology. There needs to be multiple specialized spaces and programs available to the students struggling to complete their education such as robotics lab, music production, and theater arts. Many of these troubled students need these programs to serve as an outlet for them. With specialized programs in place, this may better prepare students to transition directly out of high school with some skills to find employment since most of the students will not attend college. The school is in need of an actual STEM lab, a breakaway area to search students before entering the building.

The staff expressed some safety concerns on the campus with a huge problem with rats. The portables are disconnected from the intercom system or fire alarm system. In general, the intercom is poor where

half of the students cannot hear the announcements, and is especially critical in the event of an emergency such as a lock down situation. The staff do not feel safe in a building where part of it is condemned. The quality of the air is a major health concern with students constantly becoming sick. Surveillance cameras throughout the campus is extremely poor with resolution and locations with blind spots. The buzzer system to the front of the building requires someone from administrative office to leave their desk to open the door for visitor. Exterior lighting is poor throughout the campus, especially between the gym and main building.

There is a concern with making major renovations to the campus since it was Anderson High School and still holds class reunions. With a large portion of the campus considered condemned, the need would be for severe renovations and restoration to preserve the school.

The most critical issues for the campus is to address the condition of the facilities. The school is need of more and updated technology to students and staff. The safety and security of the building needs to be addressed including accessibility. There is a need to have updated technology and sufficient power capacity availability to all students and staff. Classrooms need to be more spacious and flexible for collaboration and independent learning.

#### **Assessment Findings**

The Educational Suitability Assessment of Alternative Learning Center earned a 42% overall score and places the campus in a category of unsatisfactory. The assessment consists of 11 categories to determine areas that need more attention.

#### **Lower Scoring Categories:**

#### **Academic & Co-Curricular Support**

The score is very unsatisfactory.

The science labs are in poor condition. One classroom has been converted into a computer lab and lacks appropriate furniture and equipment. The water and gas do not function in a science classroom. Support space for the science room are connected, but too small and overcrowded. The gym is remote from the other part of the habitable building and is not well configured and is inadequate in size. The stage area exists but is unused. The art and computer room is very small and lacks appropriate equipment and storage. Special education classes take place in small, elementary sized portables and lack appropriate storage. The cafeteria is moderate in size with poor quality of seating. The cafeteria serves as the screening area in the mornings.

#### **Future Ready Student Development**

The score is very unsatisfactory.

The campus has no dedicated spaces for hands-on project based learning. Storage is minimal casework and is an average amount of display space with some in hallways and classrooms. There are no spaces to support career education or simulate real world environments or dedicated areas for informal interaction, students to work independently, or collaborative spaces.

#### Security

The score is very unsatisfactory.

The location of the central office is located close to the entry to the school but there is no secure vestibule. Additional lighting is needed as well as camera upgrades.

#### **Exterior**

The score is unsatisfactory.

Buses, cars and pedestrians are separate. Outdoor learning spaces do exist but need some paving repairs. The playground is far from the school and gym. Signage is visible but not apparent.

#### **General Building**

The score is unsatisfactory.

Circulation routes of primary corridors are only 7-8 feet wide. Access to the gym and cafeteria is not clear for visitors from parking lots. The appearance of the campus is poor.

#### **Technology**

The score is unsatisfactory.

Within the classrooms there are a few computers and/or devices with a mix of new and outdated technology. The amount of power and data connectivity is limited for only the teacher.

## Storage

The score is unsatisfactory.

General building storage has minimal storage rooms. A large portion of the building is considered condemned and existing storage is being used by the district. Book shelves and filing cabinets serve as storage in the classrooms.

#### **Furniture, Fixtures & Equipment**

The score is unsatisfactory.

The furniture is outdated and in worn condition, scratched and marked and not flexible. The desks are attached to chairs.

#### Library/Media Center

The score is average.

The library is in decent condition but is it small and is best suited for smaller groups. The technology is not well supported with insufficient amount of computers.

#### **Environmental Quality**

The score is average.

The acoustics are inadequate as sounds are easily heard from the corridor and adjacent classroom spaces. Most classrooms and learning spaces have access to natural lighting with limited views. The artificial lighting is average with low foot candle reading with minor glare. The campus has a huge rat issue and foxes are living under the building. There is an odor throughout the building.

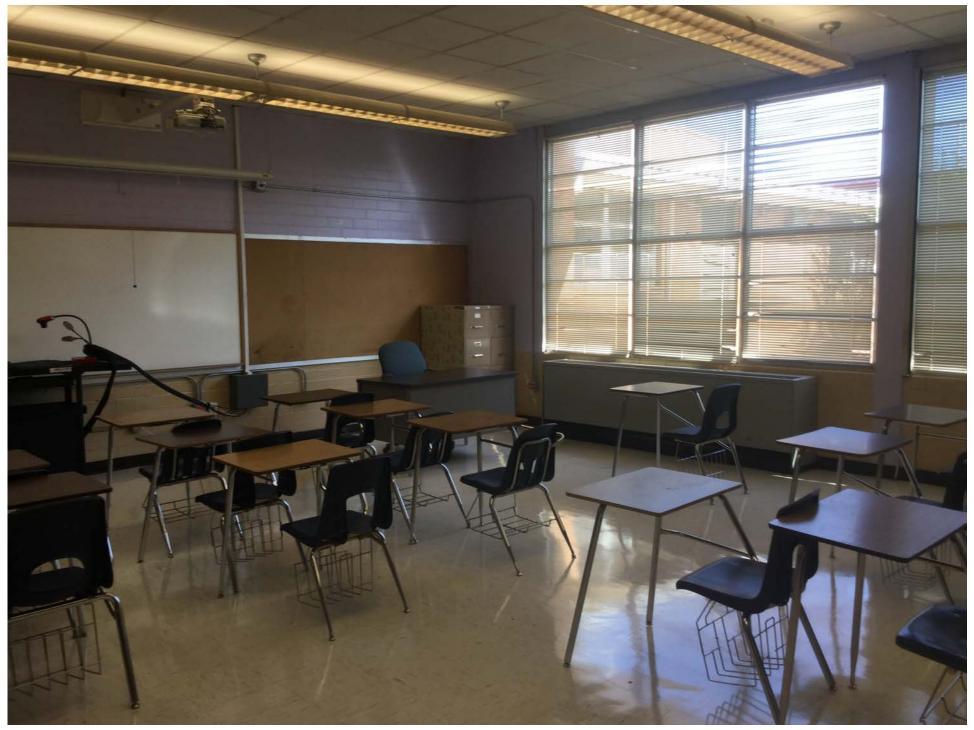
