



## **Educational Suitability Summary Report**

Martin Middle School

Date: 08/15/2016 Score 46% Unsatisfactory

Martin Middle School, serving a student population of approximately 450 students in Central Austin, is a campus that offers classes in robotics, animation, and web design. From the in-person interview, the faculty pinpointed the highest priorities as improving campus restrooms and the gymnasium bleachers, eliminating the pest issues, and upgrading the technology and instructional tools across the campus.

#### **Survey Overview**

The survey for staff and community members received no responses.

#### Interview Overview

The in-person interview conducted at Martin Middle School was attended by faculty members and the principal, Monica De La Garza-Conness, to discuss the educational suitability of the school. Some of the spaces that were described as unsuitable include the poor condition of campus restrooms, the undersized library, and the lack of storage areas. The campus is missing appropriate meeting and conference space as well. In some of the classrooms, the instructors lack appropriate instructional tools such as projectors and whiteboards. The classrooms need additional electrical capacity and data connectivity. The faculty also report that one portable currently houses SBS which is undersized for its needs.

The faculty expressed a desire for improved equipment in the weight room including TRX bands for the walls and upgraded water fountains for the campus. They would also like increase whiteboards and tack boards in the gymnasium and other common areas for instruction and display. They desire improved instructional tools for classrooms with Edu-displays being their ideal choice in technology. The restrooms on campus are in need of improvement including adding doors to the courtyard restrooms. They also would like a quiet area that can accommodate testing.

The safety concerns for the campus include the lack of adequate video surveillance. The sound system needs improvement as well to be able to communicate with the back portion of the campus. The main office is down the main hallway without visibility of those entering the school. This is not adequate for ensuring safety. The faculty also report pest issues in the form of ants, rats, bats, and roaches. There is mold reported in the band space as well. In the gymnasium, the bleachers are not up to code and are causing student injuries. For the exterior areas, the faculty requested additional signage that will clarify the hours the track space is actually available for public use.

The murals on the campus are important to maintain in the event of any future renovations or changes. The faculty predict that in the future, health is going to be important to give students access to equipment that they may not have otherwise. They also predict that creating nice outdoor learning

spaces to promote holistic education will be critical. They imagine that learning spaces will become increasingly flexible and promote individualized learning.

The most important priorities for the faculty at Martin Middle School are to improve the campus restrooms, replace the gymnasium bleachers, eliminate pest issues, and improve instructional technology throughout the campus.

#### **Assessment Findings**

The Educational Suitability Assessment of Martin Middle School earned a 46% overall score and places the campus in a category of unsatisfactory. The assessment consists of 11 categories to determine areas that need more attention.

Lower Scoring Categories: Very Unsatisfactory and Unsatisfactory Categories

#### **Storage**

The score is very unsatisfactory.

The general building storage is limited. Some of the classrooms feature minimal built-in cabinets that are in aged condition, and others lack any built-in storage at all. They are supplementing the lack of storage with outdated cabinets and shelves in classrooms. Student storage in the school is limited to some outdated lockers.

#### **Environmental Quality**

The score is unsatisfactory.

The quality of the artificial lighting is appropriate in most classrooms. Some classrooms in the main building have small windows that bring in very limited natural light and limited exterior views, while others lack any windows. There are some pest issues reported by school administration in the form of ants, rats, bats, and roaches. The acoustics are inadequate, as sounds are heard between adjacent classrooms and corridors.

### **Technology**

The score is unsatisfactory.

There is a mix of older and newer technology in the form of some older projectors and a newer Edu-display that was donated to the school. There are rooms that still only have outdated chalkboards and tack boards. There is an inadequate number of power outlets and data ports in learning spaces. This, along with the electrical capacity of the building, is a reported concern for administration.

## Furniture, Fixtures & Equipment

The score is unsatisfactory.

The campus has outdated furniture that is in poor condition. The furniture is inconsistent throughout the classrooms and is not easily reconfigurable for different group sizes. Many classrooms have attached desk and chair combinations that are not easily rearranged.

#### Security

The score is unsatisfactory.

The location of the central office does not create a secure vestibule for the campus; and it is not located at the front entry. This creates difficulty supervising anyone entering the school. Key card access is at most major entries, but the interior transparency is inadequate for faculty supervision within the school. The site lighting and video surveillance needs upgrades. The staff report that they would like new signage that would notify the public that they must refrain from using the athletic spaces until after school hours.

### **Controllability of Systems**

The score is unsatisfactory.

The classrooms do have some thermal controls, but many windows lack effective blinds for natural light control. There is inadequate artificial lighting control for the classrooms in the form of one on/off switch.

#### **Future Ready Student Development**

The score is unsatisfactory.

The campus classrooms and support spaces are inadequate to accommodate hands-on project-based learning. The storage in the classrooms is inadequate and dated. The campus lacks common spaces for vary group sizes or individual work. The library space is the only area for collaborations, but it is undersized. The facility lacks consistent visual communication tools across the classrooms, and many rooms still have outdated chalkboards and tack boards. There are some projectors but some of this technology is quite outdated.

## **Academic & Co-Curricular Support**

The score is unsatisfactory.

The campus restrooms are dated and have strong odor issues. Restroom improvement is a high priority. The science classrooms do not meet the requirements of the educational specification. Many science classrooms lack adequate classroom space and have inappropriate furniture. The athletic spaces are in good condition, but the bleachers need to be updated due to safety concerns. The weight room equipment needs updates as well. The cafeteria stage needs to have ADA access. The band space is an adequate space, but has a musty odor and the faculty report some mold issues in this area. The practice rooms need acoustic upgrades. The art room is an adequate space, with undersized support space. The kiln in located within the storage area and does not appear to be in use. The special education spaces are inadequate in condition and configuration. They lack appropriate restroom facilities with a changing area, shower, and accessible toilet area.

## Higher Scoring Categories: Average Categories

#### **General Building**

The score is average.

The configuration of the cafeteria and gymnasium allows these spaces to be secured from the rest of the classrooms and accessed for community events. The hallways are about 8'-0" wide and have adequate lighting. However, the general school appearance is aged and in poor

condition.

## **Library/Media Center**

The score is average.

The library is located somewhat far from the main entry, but central to the classrooms for convenient student access. The library has some space and flexibility for collaborative work of different group sizes. There is a tiered seating area for more informal interactions, and some available technology that will need updates in the coming years.

#### **Exterior**

The score is average.

The vehicular circulation for buses, cars, and pedestrians is separated, but the stack space is small. There are some outdoor spaces such as a chicken coop, greenhouse, and some small gardens. The track is a nice space, but the faculty would like additional signage to clarify the hours that the public is not allowed to be using this facility.


