Item 2: Questions and Answers

1) Are the **Original Bid Bonds** to be sent to the address indicated to arrive and be received by your office <u>before</u> the Bid Time?

Answer: The original bid bonds must be post marked the due date of the solicitation (May 12th, 2020). The original bid bond must be present in order for full responsiveness to be determined.

- 2) In review of the specs and drawings the spec's call out porcelain enamel writeable surface, would you like for the writeable surface is full height (18') of the panel or inset?

 Answer: Door schedule updated height of the operable partitions from 18' to 8'.

 Sheet A64-01 Door schedule revised to reflect the correct height.
- 3) While processing the Documents for this project we noticed that they were missing spec section 282320. Please advise.

Answer: Specification Section not applicable. Table of Contents revised and updated.

4) Please clarify the Phases. Sheet G03-01 Calls out Area B as Phase I and Area A as Phase II. Some of the notes on Sheet A04-01B Calls out some items of work in Area B to be in Phase II.

Answer: Refer to Alternates 01 23 00 specification for narrative description of Phase II scope of work for clarification.

- 5) When school is in session, is any of the work required to be done after hours or can we work in all areas from 7:00am to 4:00pm?
 - Answer: No. All work can be done during normal hours.
- 6) According to drawings, there is not an IDF room or network cabinet in Area B. Please confirm that all cables in Area B are landing in the server room in Area A. If so please confirm how these spaces will connect (via J hook pathway through "No work area" or conduit pathway through outdoor classroom.) If not please provide detail for equipment, backbone cable and landing point for data cable in area B.

Answer: J-hook path through no work area to existing IDF to be field located.

- 7) In project specifications (27 10 30 p. 6-8), spec calls for Systimax solutions, NO EXCEPTIONS, then calls for Panduit faceplates and hardware which would require Paduit jacks, patch cords, etc. Please confirm which manufacturer owner prefers.

 Answer: Data Cabling is Systimax, no exception. Provide Systimax equivalent for any Panduit part numbers listed.
- 8) Is the existing Roof under warranty, if so who is the warranty holder?



Answer: Most of this campus is under warranty until 2026. Information about the warranty holder is currently unavailable.

9) Are there any proprietary vendors?

Answer: No, but you will need AISD approval on items that are listed as "X manufacturer/model or approved equal". Equals/alternates need to be submitted at the time of bid.

10) Will any vendors be by AISD direct, such as Data, Security? **Answer: Unless listed as "by owner", the answer is no.**

11) Sheet A12-01A appears to be missing symbols on the RCP Legend (general note, assuming legend on sheet A12-01B applies).

Answer: Sheet updated in Addendum 01 to reflect same symbols as A12-01B.




Item 3: Site Visit
