Preliminaries

Superintendent Briefing

- Interim Superintendent Matias Segura had Ms. Heather Petruzzini speak about the following:
 - Celebration of Black History Month
 - Next steps for Bond construction of campuses

TAPR

- A review of the previous year's data was presented and for 2021-2022 an accreditation status was not assigned. These data points are based upon the STAAR and EOC scores 3rd 11th grade.
- AISD Accountability rating is a B 88 for the previous school years' data points and the Special Education states noted needs assistance.
- Members had comments that centered around teacher retention rates and how we can retain our current staffing. Comments also centered around the B rating and how we as a district needed to ensure that ALL campuses were passing.

Budget

- This was a follow up presentation from the Chief Financial Officer to review the priorities as AISD begins the next budget cycle 2023-2024.
- HB 3 tax compression
- Our district is focusing on increasing the per pupil allotment. That potential funding would go to compensation for teachers.
- AISD gives to recapture 886 million and operates on 806 million. Of that 806 million 86% of our budget goes to payroll costs. The goal is to provide a 5% pay increase for teachers.

SPED Update

- Items that are guiding the work of SPED is the Stetson Report that was published and presented to the Board of Trustees in 2022.
- Priority Pillars are Leadership, Instruction, Staffing, Capacity Building, and Family Engagement
- Recruitment and Incentives for LSSP up to \$20,000 of an annual incentive for meetings targets.
- Members would like to more information about evaluations and the status of the district.
