Prekindergarten for 3 -Year-Olds a state-mandated program serving children who are three years old on or before September 1st who:

- ~ are Limited-English speaking; or
- ~ are military dependents; or
- ~ are from families that qualify for free or reduced lunch; or
- ~ are homeless; or
- ~ have ever been in the conservatorship of the Department of Family and Protective Services

Eligible students attend the PPCD program at no cost to the family.

Preschool Program for Children with Disabilities (PPCD) PPCD is a program that serves children between the ages of three and five who have delays in the areas of speech, language, physical, social and/or emotional development. Eligible students attend the PPCD program at no cost to the family.
