**Tuition-Based Pre-K 4** Children, who are four years old on or before September 20<sup>th</sup> and who do not qualify for either PPCD or the prekindergarten program provided for qualifying students, are eligible to enroll in the tuition-based prekindergarten program at participating elementary schools. A description of the qualifying guidelines for state-mandated is included on the reverse of this form.

**If you are enrolling your child in the tuition-based PK 4 program, please read and initial each statement below.**  
**I agree to the following:**

- \_\_\_\_\_ **There is a non-refundable deposit of \$275 which will be drafted once an application is approved.** The deposit will be applied to the first month's payment.
- \_\_\_\_\_ If you also apply for the qualifying program the deposit will not be reimbursed so, please choose one option.
- \_\_\_\_\_ **Tuition payment arrangements must be made before the first day of starting class.**
- \_\_\_\_\_ I understand that this is an educational program, and that my child must remain at the school for the full school day (check campus for hours). Students with ten absences/and or tardies may be dropped from the program at the discretion of the campus administrator and the Early Childhood Director. The schedule of the prekindergarten program will follow the AISD school calendar. If I decide to enroll my child in an afterschool program on campus, there will be an additional cost.
- \_\_\_\_\_ I understand that prekindergarten begins with a visitation period and that my child may not begin full time classes until the second week of school. There will be no pre-K classes available on school holidays and teacher in-service days.
- \_\_\_\_\_ Any concerns regarding behavior management with my child at school will be discussed with appropriate school staff and me. If my child has persistent behavior problems that interfere with the general welfare of my child or others, my child may be temporarily or permanently removed from the program.
- \_\_\_\_\_ Breakfast and lunch are NOT included in the cost of tuition. I may choose to provide these meals myself or purchase the standard tray breakfast and/or lunch from AISD Food Services at an additional cost.
- \_\_\_\_\_ **I will notify AISD two weeks in advance if I plan to withdraw my child from the program.** I understand that any refunds will be on the remaining months only. **Please email your notice to [diana.perez@austinisd.org](mailto:diana.perez@austinisd.org)**
- \_\_\_\_\_ Tuition is due on the payment scheduled dates. If my child is withdrawn from the program for any reason after attending one day of class in a month, no refund will be given for that month.
- \_\_\_\_\_ I understand that my child may be removed from the program after one late or missed payment. I understand that every late payment will incur a fee of \$20 and all other expenses related to collection for delinquent payment.
- \_\_\_\_\_ Tuition acceptance letter is sent via email to the address listed above please check junk folder if not receive by April 1<sup>st</sup>.
- \_\_\_\_\_ **I understand that I will need to apply for a transfer if I wish to keep my child on this campus for kinder if the campus is frozen and be subject to all the provisions of the AISD transfer policy.**

**Please read the program eligibility descriptions below. If your child meets the guidelines below, please register at your home school campus in April. The tuition program is for those students who do not meet any of the guidelines below.**

**Prekindergarten** --a state-mandated program serving children who are four years old on or before September 1<sup>st</sup> who:

- ~ are Limited-English speaking; or
- ~ are military dependents; or
- ~ are from families that qualify for free or reduced lunch; or
- ~ are homeless; or
- ~ have ever been in the conservatorship of the Department of Family and Protective Services

Eligible students attend the PPCD program at no cost to the family.

**Preschool Program for Children with Disabilities (PPCD)**-PPCD is a program that serves children between the ages of three and five who have delays in the areas of speech, language, physical, social and/or emotional development. Eligible students attend this program at no cost to the family.
