Tuition-Based Pre-K 3 Children who turn three years old on or before September 1st and who do not qualify for [ECSE](#) or the state-mandated Pre-K program provided for qualifying students, are eligible to enroll in the tuition-based Pre-K program at participating elementary schools. Please read and initial each statement below. I agree to the following:

	A non-refundable deposit of \$275 will be drafted once the application is approved. The deposit will be applied to the first month's payment.
	If you also apply for the qualifying program the deposit will not be reimbursed, so please choose one option.
	Tuition payment arrangements must be made before the first day of starting class.
	I understand that this is an educational program, and that my child must remain at the school for the full school day. Students with ten absences and/or tardies may be dropped from the program at the discretion of the campus administrator and the Early Childhood Director. The schedule of the Pre-K program will follow the AISD school calendar. If I decide to enroll my child in an afterschool program on campus, there will be an additional cost.
	I understand that Pre-K begins with a visitation period and that my child may not begin full time classes until the second week of school. There will be no pre-K classes available on school holidays and teacher in-service days.
	Any concerns regarding behavior management with my child at school will be discussed with appropriate school staff and me. If my child has persistent behavior problems that interfere with their general welfare or others, my child may be temporarily or permanently removed from the program.
	Breakfast and lunch are NOT included in the cost of tuition. I may choose to provide these meals or purchase the standard breakfast and/or lunch from AISD Food Services at an additional cost.
	I will notify AISD <u>two weeks</u> in advance if I plan to withdraw my child from the program. I understand that any refunds will be on the remaining months only. Please email your notice to pktuition@austinisd.org
	Tuition is due on the payment scheduled dates. If my child is withdrawn from the program for any reason after attending one day of class in a month, no refund will be given for that month.
	I understand that my child may be removed from the program after one late or missed payment. I understand that every late payment will incur a fee of \$20 and all other expenses related to collection for delinquent payment.
	Tuition acceptance letter is sent to my email address listed above by April 1 st
	I understand that I will need to apply for a transfer if I wish to keep my child on this campus for kinder if the campus is frozen and be subject to all the provisions of the AISD transfer policy.
