You have access to a customized website that offers a full range of tools and resources on behavioral health and worklife balance topics. Most sections of the website are available in Spanish. Website links include:

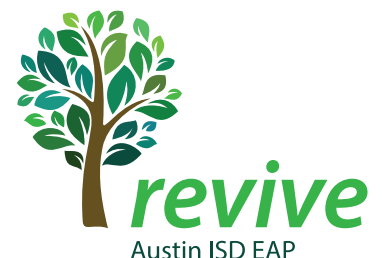

You can also receive a discount of 25 percent off tax preparation services.

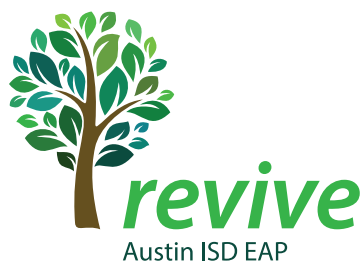
