Facility Summary


Sanchez Elementary School in east Austin is undergoing a full campus modernization project as part of the 2017 bond program. This assessment is based on construction documents and renderings of the space. The school building is approximately 80,700 square feet on 9.5 acres and will have a capacity of 580 students. The renovation is keeping the existing footprint of the school intact (1976 and 1989 construction) but is demolishing and replacing all portions of the interior space. It is adding windows to the exterior walls to allow in additional daylight.
