Kealing Middle School, serving an enrollment of approximately 1,280 students in east Austin, is known for its magnet math, science and liberal arts programs for sixth through eighth grades. The building was originally constructed in 1986 with a stand-alone studio building completed in 2007. The campus has a total of approximately 193,000 square feet. The city block in which the school is located also contains the Carver Branch of the Austin Public Library and the George Washington Carver Museum, Cultural and Genealogy Center. The signature programs on campus are Advancement Via Individual Determination (AVID), Creative Learning Initiative, middle school geometry, and social and emotional learning.

The school celebrates its history as the first junior high school for African American students in Austin. Large display areas in the main lobby contain historical imagery of students and faculty at the school. A wide variety of murals have been created across campus, showing pride in the history and growth of the community and students.

Kealing offers a variety of academic programs, including more than 80 electives. Many of these programs take place in typical studios or work areas that have been retrofitted. Often, these spaces are too small and lack the required infrastructure for the function they are providing. Many of the studios have minimal daylight or views, and some have none at all.

#### **Interview Overview**

The discussion with Kealing Academy Director Timothy Estes covered what is working well and what could be improved at Kealing Middle School. In general, the school lacks areas for students to collaborate in larger groups. It was noted that the library is too small, and its current configuration only allows about 15-20 students at a time. (From the assessment walk, this appears to be an outcome of the number of bookshelves as well as single-use desks for COVID-19 protocols.) The cafeteria is sized for an elementary school. Five lunch periods are needed to serve all students. The theater houses 200, requiring grade-level assemblies to be split into two groups.

The school needs more dedicated spaces to house its diverse elective offerings. Robotics is very popular, but they have trouble fitting 25 students in a studio. Guitar has no dedicated room and is forced to occupy different spaces as they are available.

Outdoor learning at Kealing takes place in a variety of spaces. The courtyard between the main building and the cafeteria is popular, but some of the furniture is rusting and needs to be updated. A shaded, outdoor studio is dedicated to PE and other teachers have requested additional covered studios. The learning garden is in good condition, but additional seating would be helpful to host more students.

#### **Assessment Findings**

The Educational Suitability Assessment of Kealing Middle School earned a 57% overall score and places the campus in a category of Average. The assessment consists of seven General Building categories and eight Academic categories to determine areas that need more attention.

#### **Academics & Learning**

Score is unsatisfactory.

Many of the studios are undersized and have limited flexibility to support different group sizes or teaching methods. Studios lack transparency and connectivity to other studios or shared learning spaces. Corridors are wide, but do not have any breakout spaces or informal seating. Special education spaces are too small and not all rooms have access to an accessible restroom. In general, special education spaces do not have adequate support spaces.

#### **Media Resources**

Score is unsatisfactory.

Per Ed Spec, the library is well-sized, but fixed bookshelves and bulky furniture make it difficult to accommodate different group sizes. Some informal seating is present, and the layout might be reduced due to COVID-19 concerns. Several small rooms are connected to the library, but currently none are being used as breakout spaces for small groups or individual learning. Technology in the library is limited to a very small projector screen and a TV on mobile cart.

#### **Technology**

Score is unsatisfactory.

Technology is not well-supported in the learning spaces. Many studios have very small projector screens and small televisions with attached VCRs. Studios that have incorporated the large, mobile flat-panel televisions have trouble fitting them in already cramped rooms. There are no centralized charging stations. Students use extension cords plugged into the limited number of wall outlets.

#### **Exterior**

Score is average.

The building has separate drop-off areas for parents and the majority of buses. The special education buses pick up in the parent parking lot in the rear of the school.

#### **General Building**

Score is average.

The building is well-configured for hosting sporting and performance events. The gym, theater and cafeteria are housed in a separate building with a large entry space accessed from the parking lot. Hallways throughout the school are over 10 feet wide, and a large, double-height space with stairs connects the two levels of the building.

#### **Environmental Quality**

Score is average.

Most studios have access to some natural light, but much of it is through clerestory windows that limit views. The two building wings are positioned so closely together that some studios only have a view of the wall of the adjacent wing.

#### **Controllability of Systems**

Score is average.

Each studio has thermostats to control temperature. Most have only one light switch controlling all lights (on/off), but some studios have two lighting zones. Blinds in the studios are old and in poor condition.

#### **Furniture, Fixtures, Equipment**

Score is average.

Furniture varies widely from one studio to the next. Some areas have older configurations with chairs and attached desks, while others have loose chairs and bulky tables. Common spaces have little variety in seating options, although the library does have a small amount of mixed informal seating.

#### **Athletics and Wellness**

Score is average.

The school's main gym is well-sized and in generally good condition. The bleachers are permanently stuck in the out position, which limits flexibility of the space. Lighting and climate control are issues in the gymnasium. The track and field is 2/3 the size of a regulation field, meaning the school cannot host several key sports. The school's three tennis courts are in adequate condition.

#### **Food Services**

Score is average.

The cafeteria is too small for the number of students at Kealing, requiring the school to have five lunch periods. A large, outdoor dining area with additional seating is next to the cafeteria.

#### Satisfactory Categories (66-80%):

### **Outdoor Learning and Activity**

Score is satisfactory.

Two dedicated outdoor learning studios are on the grounds: one shaded structure is for PE only, and

another small outdoor studio has photovoltaics contributed by Austin Energy. The learning garden is in good condition but is disconnected from the learning spaces. A small shed provides storage and infrastructure for the garden. A rain collection cistern is provided.

#### **CTE and Career Connected Learning**

Score is satisfactory.

Kealing has a wide variety of CTE programs, offering more than 80 electives to students. Some of these are housed in purpose-built areas such as the machinery and wood shop or the A/V program. Many other programs are in typical retrofitted studios.

#### **Visual and Performing Arts**

Score is satisfactory.

The theater stage is in good condition but lacks storage and seating for a school this large. Orchestra and band are in well-sized, dedicated rooms. Additional storage for instruments is needed. Choir and the black box theater take place in typical studios that have been retrofitted.




