Superintendent Segura and Board President Boswell,

Thank you for submitting your final, board-approved campus turnaround plan for **Widen Elementary** (CDCN: 227901175). We appreciate the time and effort that you, your staff, and your community have put into developing a plan to improve the academic outcomes of all students in your school system.

While we commend your commitment, the submitted turnaround plan lacks sufficient detail to demonstrate readiness to implement a school improvement strategy that ensures the campus will meet all student performance standards under TEC §39.054(e) within two years.

The plan may be approved upon resubmission if the revised turnaround plan includes sufficient evidence in the following areas:

Resources

The plan does not provide sufficient evidence that all necessary resources have been identified and aligned to support successful implementation. Specifically, the review found:

- Funding sources for listed costs are not specified.

Closure and Reassign

The plan does not provide sufficient evidence that student reassignment processes are comprehensive and ensure continuity of high-quality instruction and support. Specifically, the review found:

- Clear and evidence-based plan to support students reassigned to the D/F campus is not included.

Your school system is required to modify and resubmit the turnaround plan during the resubmission window: March 10-24 to address all elements identified as lacking sufficient detail to improve academic outcomes within two years of implementation. Please submit the updated TAP by **March 24, 2026** using the Qualtrics form that will be emailed to Superintendent Segura on **March 10, 2026, at 8:00 AM**. To support your revision process:

- Use the TIP/TAP Planning Workbook Tool and the 2025-2026 Turnaround Plan Success Criteria located on the School Improvement [Campus Accountability Interventions and Guidance webpage](#) to guide your revisions.
- Reference the initial PDF submission sent via email at the time of your original Qualtrics submission to begin planning specific changes aligned to the feedback provided in this letter
- Ensure all statutory and implementation requirements are fully addressed in the modified plan.
- Submit the revised TAP by **March 24, 2026**, via Qualtrics form.

Following submission, TEA will review your revised Turnaround Plan within 15 days and provide written notification of final approval or rejection. If the revised plan is not approved, the commissioner is required by law to implement one of the interventions outlined in TEC §39A.107(c), which may include appointing a board of managers, ordering alternative management of the campus, or ordering campus closure.
