# **Meeting Agenda and Discussion**

## 1. Call to Order, Attendance, Quorum (6:00 PM)

- 1.1. Call to Order: Deb Trejo called the committee to order at 6:00 PM.
- 1.2. Quorum: A quorum was met. 17 members were present.
- 1.3. Approval of the Minutes: Deb Trejo asked for approval of the minutes. Bree Rolfe made a motion to approve. Kellie Marino seconded the motion. All approved.
- 1.4. Membership Updates: Ricardo Bentin requested clarification for members on renewal of membership and end of term. Cherry Lee clarified the requirements of the terms. Kellie Marino will send individual emails to members with their term status and next steps options.

## 2. Member Comments / Public Comments (6:00 PM)

• 2.1. Public Comment: No public comment was recorded on the form.

 Deb Trejo read into public comment an email from Lisa Flores regarding a letter to the AISD Board from CBOC relating to Cameras in Special Education spaces.

#### • 2.2. Member Comments:

- Trasell Underwood raised a concern about the TEA Monitors in attendance at SEFAC and how their presence could hinder authentic conversation. Sherry Marsh, TEA Monitor, responded with clarification about the role as part of the TEA Agreed Order. Deb Trejo suggested a followup conversation with District staff about requirements. Randi Shade commented with no concern about having the TEA Monitors in attendance.
- Elexa Martinez elevated a conversation from the previous meeting about
  Special Education students being able to follow their feeder pattern under the new consolidation and boundary adjustments. Deb Trejo recommended this conversation be moved into committee.
- Ali DeVeny requested transparency for Special Education staff about what is happening under the consolidation and boundary changes with Special Education programs and services. She also advocated for district guidance for case managers on how to have conversations with families about these changes. Deb Trejo recommended this conversation be moved into committee.
- Deb Trejo discussed clarity and questions with dually classified students, receiving Dual Language and Special Education, during the consolidation and boundary changes. Deb Trejo recommended this conversation be moved into committee.

## 3. Strategic Plan Updates & Review (6:20 PM)

- 3.1. Status Update & Review of Campus Based Evaluator Model: Update and review were provided by Amanda Reyes, Director of Evaluations.
  - Amanda Reyes provided information on the changes made this year to the evaluator model and requested feedback from SEFAC on questions that could be asked to families on their evaluation experience.

- Deb Trejo posed questions to get clarity on the ask for feedback. Amanda Reyes responded.
- Kellie Marino shared the feedback document with SEFAC to add their questions.
- Cherry Lee added a request for SEFAC to send her any specific updates or questions about evaluations that would be pertinent to the Board Update in January.

- Ricardo Bentin, Randi Shade, and Bree Rolfe offered comments and discussed the difference between transition services for students with disabilities and advancement across grade levels/schools as something to consider in future work opportunities for the Transition Work Group.
