**Minutes:** May minutes passed.

### Youth Services Mapping Presentation:

BiNi Coleman, Administrative Supervisor, Partnerships, AISD, presented a report on Youth Services Mapping (YSM). YSM is a full inventory of all the youth services in Central Texas. It was created through an AISD grant to coordinate services systemically across the region. It is a way of centralizing information on who is doing what on our campuses with our kids. AISD has formalized a partnership with organizations to be included in the YSM. There are 15 service categories including basic needs, behavioral health, etc. Parents and community members are able to do a search related to specific schools and map services nearby. It also shows services that are available upon request. This has program profiles, contact information, which outcome measures are tracked, and locations.

Julie Cowan asked who was using the YSM, and BiNi said it was mainly departments and campuses in AISD. BiNi encouraged everyone to access the site. It also can be translated into other languages. Parent support specialists have the information. Any provider can enter in community-based sites. Nekosi Nelson asked about demographic information that is reported out. The Electronic Child Study Team tool allows partners to report on who they serve, then they can get back group information de-identified to understand who they are serving.

### Committee Reports:

Health Education Committee report: Alda Santana reported on the new human sexuality curriculum revision. She stated the law and AISD policy on sexual education, along with the

elements that will be included in the curriculum. K-5 will be composed of five lessons per grade, while 6-12 will have 10 lessons per grade. All parents and guardians will receive information ahead of time, and there will be a parent orientation night at each campus conducted by principals. Parents will be provided the opportunity to opt their child out of any or all lessons. The curriculum will be available for review in the school libraries. The curriculum stakeholder group was conducted and composed of administrators, teachers, counselors, SHAC members, and others. The group met from December 2017 to April 2018. Parents had opportunity to participate and attend the focus meeting. SHAC has received parental input. Alda read excerpts from both supporters and opponents.

Alda made the recommendation to the full SHAC.

Fernanda Santos made a motion to accept the Health Education Subcommittee recommendations and approve the implementation of the curriculum, the use of resources, and adoption of the National Sexuality Education Standards. Toni Raynor seconded the motion. Vote: 10 voted in favor-1 against-1 against

**Board Report:** Julie Cowan said they are working to get the superintendent's scorecard done, includes coordinated school health. A new citizen's committee is being put together on the budget. A lot of our district is going to start feeling some cuts. You can apply to be on the budget stabilization committee. New officers: Geronimo is president, Yasmin vp, and Julie secretary.

## District Reports

**Health Services:** The SHAC is invited to testify about the mental health centers and trauma informed care. The district has requested an additional \$15 m to expand mental health services from the governor's office. Will also be able to get info out about contracted health provider.

**Health education:** AISD got the coordinated school health report and this year, 87% of campuses scored as "recognized" or higher.

**Food Services:** AISD served 78,000 meals/day in May. Finished school year serving over 12 million meals. Summer feeding program is open to any student, no cost. More information can be found on the AISD website. 25% of our student body are food insecure. Cap Metro is providing free rides to sites.

**Social Emotional Learning:** tomorrow is the SEL symposium; also providing book studies for faculty.

**Employee Wellness:** had first quarter review for health plan. SEO plan—has saved the district \$56 million. Ready MD is having 100 visits a month.

**Student Health Services:** Staffing update: They started the year with 116 employees and ended the year with 149. This staffing increase is reflected in many of the gains in the direct care and case management throughout the school year and serves as a new baseline for future years. They are ready to fill existing vacancies once they know the school board decision on the contract. In May and June, 1,603 students were seen by nurses on school campuses. During this

same time period there were 23 confirmed cases of flu or influenza like illness. Throughout the summer, they will be redesigning the AISD staff training delivery methods to utilize human capital platform. They will also update the teaching modules used for SHS staff.
