6:30 p.m	 ▶ Immunization Update ○ Alana Bejarano shared that all campus nurses are now back under AISD, with seven nurses left to hire. ○ Immunizations are still at the forefront. MMR vaccinations are still low for kindergarteners. Herd immunity is 95% and the district is at about 93%. ○ A question was asked about how that number looks at the campus level and if some campuses are more at risk than others. Ms. Bejarano explained that the "eastern crescent" of Austin is where they are focusing their resources because of lower levels. ◆ Mental Health RFP Update ○ Dr. LaShanda Lewis shared that the RFP went out August 15, 2025; questions were due from the vendors by August 26, 2025; the district responded to those questions by August 29, 2025; and the RFP closed September 2, 2025. The AISD Procurement office has finalized the process and a top vendor was identified. That information will be sent to the Board of Trustees and they will vote in October. ○ A question was asked about how many responses there were. 	that there were 4 vendors that went through the proper process. Another question was asked about the mental health training numbers. Dr. Lewis reminded the Council that HB 3 from the 2023 Texas Legislative session required that any district staff that regularly interacts with students must complete a mental health training course. The requirement was that 25% of staff had to be trained by the start of the 2025-2026 school year. AISD was able to train 65% of staff before the first day of school. A question was asked about a grant that the district applied for to help pay for the mental health trainings. Dr. Lewis shared that they have not received an update on that grant and are not expecting to have an update until October or November. If that grant is not awarded, the district will not be able to implement the recommended Youth Mental Health First Aid program. Dr. Lewis also shared that district leadership has started some preliminary conversations about how to navigate compliance with HB 3 with the new contradictory language from SB 12. Dr. Lewis asked for the SHAC to provide recommendations on where the services from the RFP should be focused. Ms. Kelly agreed to reach out to Ann Teich, co-chair of the mental health committee, to discuss and would email a response to that question within 2 weeks.
