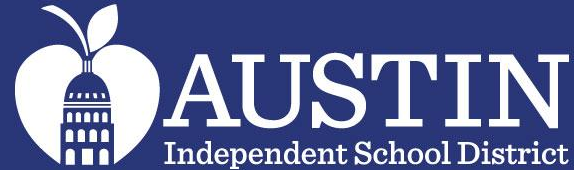

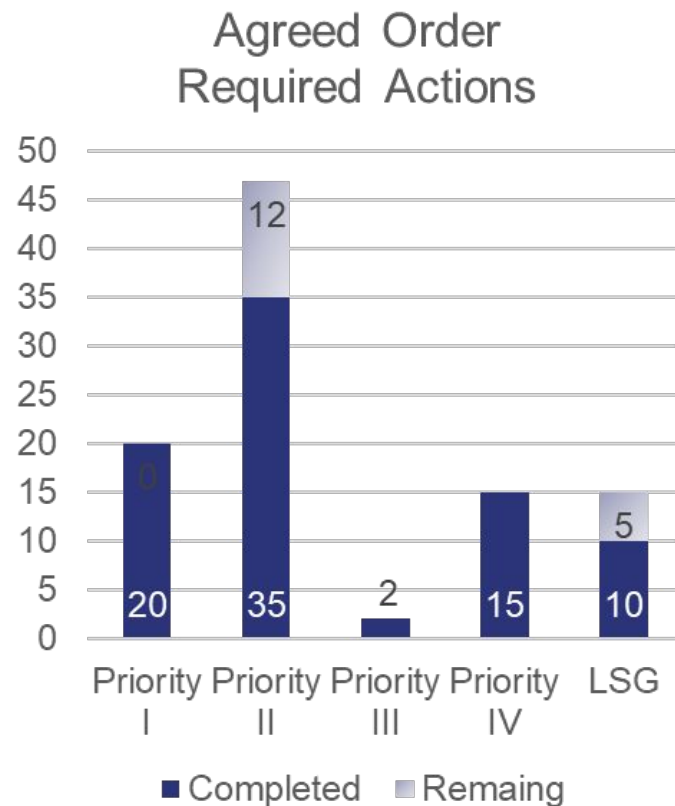

## Update

- Reporting began to TEA and Board on October 1, 2024
- Transitioning to new SPED data management system for SY 25-26.
- Train-the-Trainer Sessions for the new system, May 5-12

## Next Steps

- Training for staff writing IEPs in the summer, June 2-3
- Full go-live on July 14, 2025
- Campus leadership training during Leadership Institute, July 17
- Intensive training for all SPED teachers, August 12-14

## Priority IV: Establish a Parent Outreach Campaign

**Special Education Family Advisory Committee (SEFAC) met 6 times in the 24-25 school year.**

- Transition services for students with disabilities
- The AISD Special Education and Section 504 external website
- Family engagement and learning opportunities
- Expansion of disability awareness
- District communication efforts to include special education updates, and
- Family engagement survey (sent to families of students with disabilities)
