# Garcia Young Men's Leadership Academy 2015–2016 AISD Parent Survey Report

This report summarizes the results of the 2015–2016 Parent Survey for Austin Independent School District (AISD) for Garcia Young Men's Leadership Academy. The survey assessed parents' perceptions of their interactions with school staff; the information provided by the school about academic programs, enrichment opportunities, and future career opportunities for the students; school climate; and the quality of the food services.

The survey was available to parents in paper form (distributed to each child by hand) and in electronic form on the AISD website. In addition, the survey was available in English, Spanish, Vietnamese, Arabic, Burmese, Korean, and Mandarin Chinese.

In Spring 2016, a total of 35 parents of Garcia Young Men's Leadership Academy students responded to the parent survey. This report compares district results from Spring 2015 and Spring 2016. Unless otherwise noted, results in this report represent the percentage of respondents who strongly agreed or agreed with each item. Arrows ( $\uparrow \downarrow$ ) in the tables indicate a statistically meaningful change from the prior year. Meaningful changes were identified with a statistical computation of effect size using Cohen's h. Changes with an effect size of at least .20 were considered meaningful.

# Federal Standards for Collecting and Reporting Ethnicity and Race

Starting in 2010–2011, school districts were required to report race and ethnicity using revised standards. The new standards require a person to first select his or her ethnicity (Hispanic/Latino or not non-Hispanic/Latino) and one or more of five race values. Because more than one race value may be chosen, percentages may not add to 100.
