

## 2010-2011 AISD Parent Survey Kealing Magnet Middle School

Strong relationships among staff, students, and parents are critical to student success. In particular, parent involvement in education is associated with a high level of student achievement (for a meta-analysis see Fan & Chen, 2001). These survey results provide campuses with feedback on how parents feel about their treatment by school staff, the school's educational environment, and how parents describe their involvement in their child's education. The following report contains the results of the 2010-2011 Parent Survey for Austin Independent School District (AISD); longitudinal data are provided where applicable.

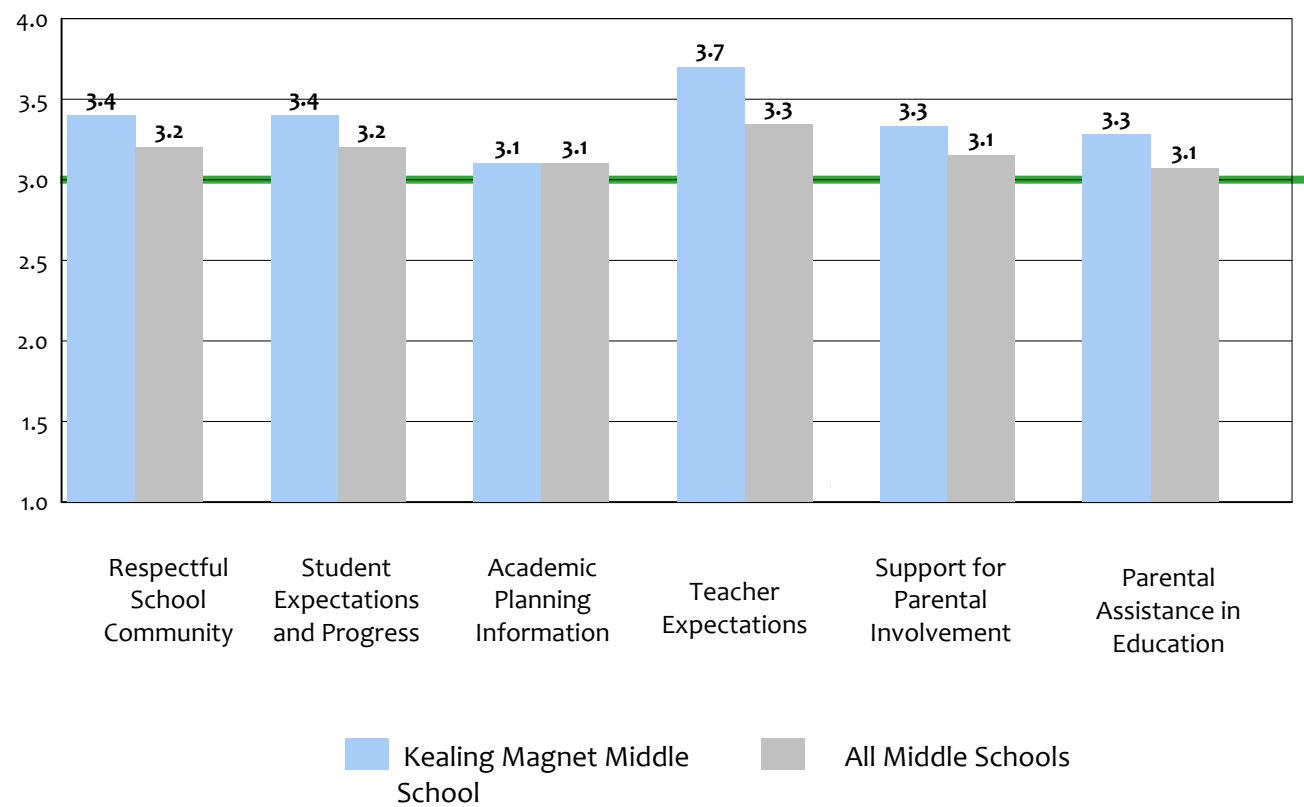
#### New Federal Standards for Collecting and Reporting Ethnicity and Race

Starting in 2010-2011, districts were required to report race and ethnicity using revised standards. The new standards require a person to first select his/her ethnicity (Hispanic/Latino or non-Hispanic/Latino) and one or more of five race values. Since more than one race value may be chosen, percentages might not add to 100.

Note. Students' grade and ethnicity were self-reported. Population data reflect enrollment as of the October 2010 PEIMS snapshot date.

A summary of Kealing Magnet Middle School survey results for the 2010-2011 school year is presented in figure 1. Scores over 3.0 are desirable, as indicated by the green line. Also, please note the green and red boxes that highlight the specific area in which Kealing Magnet most excels, as well as the area in which Kealing Magnet can improve most.

Figure 1. Parent Survey subscales for Kealing Magnet Middle School and all AISD Middle Schools, 2010-2011



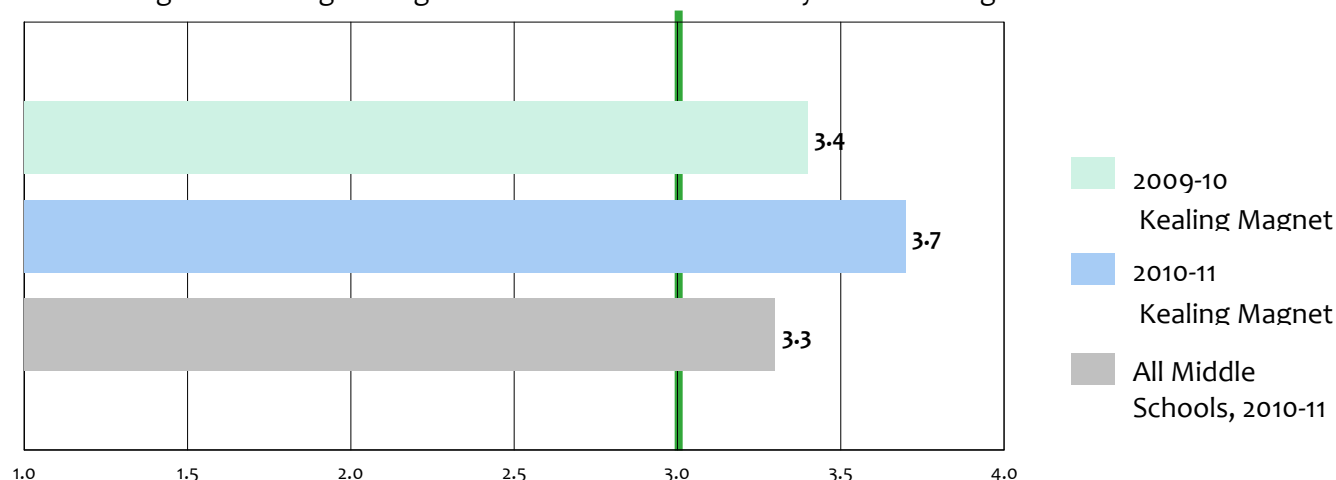
Kealing Magnet's highest score on the 2010-2011 Parent Survey was Teacher Expectations. This subscale is designed to measure expectations parents believe that teachers have for their children. We encourage your campus to continue fostering a positive learning environment with rigorous teacher expectations for all students.

Kealing Magnet's lowest score on the 2010-2011 Parent Survey was Academic Planning Information, which measures the adequacy of information and assistance that parents receive from school staff regarding their child's academic future. We encourage your campus staff to consider ways to involve parents in academic planning for their child.
